## 2. Please provide a brief description of what you are screening

The construction of the Bridgewater Place Building ("the Building) was completed in April 2007. Subsequently it became apparent that the building has had a significant impact on wind speeds in the environs of the building.

At times, the wind speeds have been accelerated to levels at which Highway users have been put at risk and in some cases actually harmed. In March 2011, Dr Slaney was tragically killed as a result of a lorry being blown over on to him by a greatly accelerated gust of wind at the junction of Victoria Road and Water Lane.

Officers have been working with the building owners and their agents since 2008 to ensure that the optimum solution to ameliorate the unacceptably high wind speeds in the vicinity of the building was identified. As a result of that work, the proposed amelioration scheme has been worked up, tested and ultimately agreed by all parties and the developers of the Bridgewater Place building were granted planning consent

in November 2014 for a scheme of wind amelioration works to address the identified issues.

Based upon the specialist advice the Council has received, authority is now being sought from Executive Board to conclude and enter into the Development Agreement with the Building Owners which includes the necessary provisions for the construction of the consented works to proceed on the public highway.

Consultation on the proposals has taken place with the following stakeholders:

- The proposed wind amelioration scheme has been subject to a planning application by the owners of Bridgewater Place which was approved in November 2014. It has therefore been the subject of a previous planning application and the associated consultation process.
- The highway works associated with the approved scheme are the subject of a Section 278 Agreement under the provisions of the Highways Act 1980 which has been endorsed by the Chief Officer, Highways and Transportation for which an EDCI screening has previously been completed.
- In accord with the EDCI screening further assessment will be undertaken during the detailed development and checking of the proposed highway works.

## Key findings

The proposed Development Agreement provides the legal basis for agreement between the City Council and owners of the Bridgewater Place building for progressing to the implementation of the wind amelioration scheme.

#### Positive Impacts

- The Development Agreement enables outstanding matters to be formally settled and for the work to be progressed to ensure the delivery of measures forecast to provide mitigation to current issues during high wind events in the environs of the Bridgewater Place building.
- The consented Wind Amelioration Scheme has been extensively tested and the proposals are expected to improve pedestrian mobility and the safety of other road users during times of high winds including those equality characteristics of age and disability most susceptible to the present conditions.

### **Negative Impact**

Necessary adaptations to the highway network to accommodate the specific wind

amelioration measures are included within the scheme and form part of the consented works and through the Section 278 agreement full attention is being given to ensure that the new highway layout continues to meet the mobility needs of pedestrians and other users of the highway within the scope of the Development Agreement.

- The Wind Amelioration Scheme includes baffle measures of a unique nature to be constructed on the public highway measures which the Developers Experts have advised there may be risk of on-going failures of the distress criterion (most of which are anticipated to be marginal failures) in a small number of locations.
- The potential for these remaining wind hot spots necessitates the retention and addition of pedestrian guardrailing at and around the junction to direct pedestrians to safe crossing points, hence potentially increasing pedestrian route lengths.

#### Actions

The proposed Development Agreement contains provision for the owner of Bridgewater Place to monitor the performance of the Wind Amelioration Scheme and defines their obligations to monitor the scheme, test its performance, review and implement such further improvements at these locations as are advised by appropriately qualified and independent experts.

The Council has required that an appropriate testing regime is implemented to ensure that the installation is working as intended. The Developer's Experts have advised that the wind effects in the locations at risk of on-going failures of the distress criterion can be mitigated by local street level modifications.

Officers have placed reliance on expert advisors throughout the planning process and the making of the Development Agreement and with advice from an independent specialist wind analyst it has been confirmed that the safeguards contained within the Development Agreement are appropriate.

Additional pedestrian facilities are being provided to ensure safe crossing locations for pedestrians.
