Summary of main issues

- 1. The Monitoring Officer is required to keep the Constitution under review to ensure that it is up to date and fit for purpose.
- 2. A recent review of the Officer Delegation Scheme (Council functions) relating to the Assistant Chief Executive (Citizens and Communities) has shown that some minor amendments are necessary for the purpose of clarification in relation to the licensing authority's functions under the Gambling Act 2005.

3. The Monitoring Officer is requested to approve amendments to the Officer Delegation Scheme (Council functions) relating to the Assistant Chief Executive (Citizens and Communities) as shown at Appendix A attached.

1 Purpose of this report

1.1 This report sets out amendments to the Officer Delegation Scheme (Council functions) relating to the Assistant Chief Executive (Citizens and Communities) which are necessary to clarify the constitution.

2 Background information

- 2.1 Article 15.2 of the Constitution provides that "the Monitoring Officer is authorised to make any changes to any Part of the Constitution which are required:
 - As a result of legislative change or decisions of the Council or Executive to enable him/her to maintain it up to date;
 - Or for the purposes of clarification only."

3 Main issues

3.1 The Assistant Chief Executive (Citizens and Communities) has the delegated authority to discharge licensing functions including certain functions delegated by the Licensing Committee. The current Officer Delegation Scheme (Council (non-executive) functions) in the Constitution identifies the Licensing Act 2003 and in the footnote the 2005 Act. The 2005 Act referred to is the Gambling Act 2005. The suggested amendment shown at Appendix A clarifies this.
