Summary of the main issues

Adopting an area of highway at Primrose Hill, Pudsey, Leeds LS28 in accordance with Section 228 of the Highways Act 1980.

Recommendations

- 2 The Chief Officer (Highways and Transportation) is requested to:
 - i) take all necessary steps to under the provisions of Section 228 of the Highways Act 1980 to declare the area of highway shown hatched on the attached Drawing SD/994652/PH/01 to be highway maintainable at public expense;
 - ii) instruct the City Solicitor to prepare and advertise notices under the provisions of Section 228 of the Highways Act 1980 declaring the area of highway shown hatched on the attached Drawing SD/994652/PH/01 to be highway maintainable at public expense and
 - iii) if objections are received from the majority of the owners of the land, request the City Solicitor to make immediate application to the Magistrates' Court for an Order overruling the objections.

1 Purpose of this report

1.1 To seek approval for advertising notices under the provisions of Section 228 of the Highways Act 1980 with a view to adopting part of the turning head and adjacent footway at Primrose Hill, Pudsey, as a highway to be maintained at public expense.

2 Background information

2.1 Work has recently been carried out to construct a turning head and adjacent footway at Primrose Hill, Pudsey, part of which is in land for which no known ownership can be traced.

3 Main Issues

- 3.1 Section 228 of the Highways Act 1980 allows Highway Authorities to adopt and declare a street to be a highway maintainable at public expense after carrying out street works.
- 3.2 It is proposed to adopt the area of highway shown hatched on Drawing SD/994562/PH/01 using powers under Section 228 of the Highways Act. If the owner of the land (or, if more than one, the majority of owners) objects to the proposal, the Council would need to apply to a Magistrates' Court within a period of two months from the expiry of the notice for an Order overruling the objections. Providing any objections can be overcome, the highway would then become adopted.

3 Corporate Considerations

3.1 Consultation and Engagement

3.1.1 Ward Members were consulted by a letter and drawing dated -. To date no responses have been received.

3.2 Equality and Diversity / Cohesion and Integration

3.2.1 The proposals will not impact on any equality characteristic more significantly than any other.

3.3 Council Policies and City Priorities

3.4 Resources and value for money

- 3.4.1 The area of highway to be adopted will become maintainable at public expense.
- 3.4.2 All staff and legal costs involved in the Section 228 process will be funded from the Children's Services Capital Program.

3.5 Legal Implications, Access to Information and Call In

3.5.1 If the owner of that land objects, the Council would need to apply to a Magistrates' Court for an Order overruling the objection.

3.6 Risk Management

3.6.1 The Section 228 Notice will be displayed on site and advertised by the Council following authorisation of this report by Highways Board. The successful adoption of the highway depends on any objections made by landowners being overruled by the Magistrates' Court.

4 Conclusions

4.1 The area of highway shown hatched on Drawing SD/994562/PH/01 should be adopted using powers under Section 228 of the Highways Act.

5 Recommendations

- 6.1 The Chief Officer (Highways and Transportation) is requested to:
 - i) take all necessary steps to under the provisions of Section 228 of the Highways Act 1980 to declare the area of highway shown hatched on the attached Drawing SD/994652/PH/01 to be highway maintainable at public expense;
 - ii) instruct the City Solicitor to prepare and advertise notices under the provisions of Section 228 of the Highways Act 1980 declaring the area of highway shown hatched on the attached drawing number SD/994652/PH/01 to be highway maintainable at public expense; and
 - iii) if objections are received from the majority of the owners of the land, request the City Solicitor to make immediate application to the Magistrates' Court for an order overruling the objections.
