I am a Police Officer in West Yorkshire Police serving at Elland Road Police Station, Leeds. I am the Licensing Officer for the North East Leeds Division, which covers the Leeds 8 area. Prior to the formation of the Leeds District Licensing Office I was stationed at Killingbeck and for a brief period at Gipton. I have worked in the North East Leeds area for the past 24 years.

I have worked on patrol responding to calls from members of the public for the majority of my service. I have tutored probationer constables in the Division again responding and dealing with calls from members of the public. More recently I have worked as a researcher in the Killingbeck Divisional Intelligence Unit (DIU) and from September 2005 I worked in the Operations and Planning Department at Killingbeck. issues in the North East Leeds area and I bring my knowledge of the area and my experience

as a Patrol Officer to my role.

Although I am based at Elland Road Police Station I liaise regularly with the Neighbourhood

Policing Teams at North East Leeds in relation to issues attributable to licensed premises. I

also liaise with other Responsible Authorities in relation to ongoing issues connected to

licensed premises and the action to be taken in relation to these issues.

One premises I am familiar with is an off licence shop called Biedronka, at 225 Roundhay

Road, Leeds, LS8 4HS. I have liaised with Carmel Brennand, from Leeds City Council

Licensing and Enforcement, in relation to this store and breaches of the premises licence and

complaints received in relation to the store.

On 1515hrs Wenesday 7 October 2015, in company with Carmel Breannand and probationer

constable PC Stephanie Van Loo we attended at Biendronka, 225 Roundhay Road Leeds 8.

This visit was a follow up inspection to visits made previously by Carmel Brennand. This was

one of a number of premises being visited where we had complaints or concerns in relation to

licensing issues.

Upon arrival we spoke to a young female member of staff and Carmel Brennand introduced us

and explained the reason for our visit. The female was alone in the store but almost

immediately Mr Amiri arrived at the shop.

As part of the inspection Carmel Brennand asked if she could view the CCTV at the store. It

was clear that there was a CCTV system in place, with four cameras installed, but neither Mr

Amiri or his member of staff could operate the system.

The premises licence has numerous conditions in relation to CCTV, which were agreed at the

time of application, and should be complied with at all times. Arrangements were made to

revisit the premises, by which time the CCTV should work and members of staff, on site,

should be able to operate the system.

Carmel Brennand also explained that a Designated Premises Supervisor (DPS) authorisation

should be in place to allow others to sell alcohol. The DPS at this time was Shoresh

Mohammed, form 11 Harehills Road, Leeds 8 and Mr Mohammed needed to authorise the

sales of alcohol. Mr Amiri said that he and Mr Mohammed were good friends and he would

make sure the authorisation was given.

Check 21 posters were also provided on the day of the inspection and Mr Amiri enquired about

opening 24 hours a day. It was made clear that the shop needed to operate correctly with the

hours it had before a variation to extend the hours would be entertained.

At 1400hrs on 4 November 2015 in company with Carmel Brennand and probationer constable

PC Alan Andrews I visited Biedronka, 225 Roundhay Road, Leeds 8. A young female member

of staff was behind the till and was asked the whereabouts of Mr Amiri or Mr Mohammed. She

explained that it was her first day at the shop and she did not know the whereabouts of Mr

Amiri and she did not know who Mr Mohammed was.

The CCTV looked as though it had been improved with six cameras rather than four. However

the sales assistant could not operate the system and details were left with her, by Carmel

Brennand, to say we would need to visit again.

At 1121 on 17 November 2015 I visited 225 Roundhay Road Leeds 8 in company with

Sebastian Roberts, an officer from the West Yorkshire Police Imaging Department. I was aware

that Carmel Brennand had communicated further with Mr Amiri and that it was strongly

suspected that the CCTV at the premises would not be working. In an attempt to try and see

what the difficulties there were with the system it was thought that a visit by the WYP Imaging

Department may assist.

Upon arrival I spoke with the same female member of staff, who was alone in the shop. Mr

Amiri was not present but there was an unknown male fliting in and out of the shop who we

were informed was 'told to watch her' whilst the owner was away.

The female member of staff showed me a letter sent by Carmel Brennand to Mr Amiri, plus a

DPS authorisation sheet. Her name was not on the sheet of people authorised to sell alcohol.

On inspecting the CCTV system it clearly showed that it had only recorded from 13 November

2015 from 1545hrs. There were six camera installed but it was not possible to access the part

of the system which showed if the system would record for 31 days to comply with the licence

conditions.

For the past year I have held the position of ward manager for the Harehills area of Leeds, and in this role I often work with partner agencies and community groups in the Harehills area. On Friday the 8th January 2016 I was working in company with senior Liaison and Enforcement officer Carmel BRENNAND, from Leeds City Council and we were conducting revisits at both licensed and non-licensed premises within the area. At 9:50hrs we attended at "Biedronika" at 225 Roundhay Road, Leeds 8. There was a young female standing at the side of the counter and a male mi now know to be Mr Amiri was seated behind the counter. Carmel and I identified ourselves and shown our identification to Mr Amiri and Carmel asked if he had received her letter telling him there would be a re-visit toady to which he said "yes," and proceeded to show Carmel his new Personal Licence. Amiri stated he would transfer the Designated Premises Supervisor into his name and take the name Soresh off it. Carmel reminded Amiri that we were here to look at the CCTV and we turned to look at the wall mounted CCTV monitor. There was 6 cameras displayed on the screen however no date or time was shown. Carmel asked Amiri if we could look at footage from the 8th December 2015, but he was having difficulty operating the system so the young female took over from him, went on to the search screen and tried to change the date. The search screen showed this in an American format of 2015-12-08 and 'No Data' was displayed on the screen. Despite several further attempts, she was unable to show any footage from the 8th December **2015**. The same female then attempted to rewind the footage from today's date back to the 8<sup>th</sup> December 2015, however the footage only went as far back as 09:00hrs on the 4th January 2016. Amiri said the CCTV was supposed to go back 31 days and he had paid the CCTV man sums of £150 and £140, at which point Carmel informed him that it was his responsibility to check the CCTV daily to make sure it was recording to 31 days and pointed out offences regarding the sale of alcohol, then reminded Amiri of his recently completed personal licence course. Amiri picked up his mobile and said he was ringing his CCTV man. A short time later he ended the call and stated," "The CCTV man is coming at 5 pm tonight, come back tomorrow and you will see that it has been fixed."
