Summary of main issues

To declare an area of adopted highway comprising a spur off Westerton Walk, Tingley, unnecessary in accordance with Section 116 of the Highways Act 1980.

Recommendations

The Chief Officer (Highways and Transportation) is requested to instruct the City Solicitor to apply to the Magistrates' Court for a Stopping Up Order under the provisions of Section 116 of the Highways Act 1980 for the area of adopted highway shown hatched on drawing SD/994715/WW/01 (Appendix A).

1. Purpose of this report

1.1 To seek approval to promote a stopping up order for an area of adopted highway, comprising a spur off Westerton Walk, Tingley.

2 Background information

- 2.1 Westerton Way is situated in Tingley approximately 8Km south of Leeds City Centre. The former adult training centre in Westerton Way has been demolished and the council intends to develop the site for supported housing.
- 2.2 The access next to 2 Westerton Way is therefore no longer needed and, as this spur is adopted highway, it will have to be legally stopped up. The area area of highway to be stopped up is approximately 100 square metres and is shown hatched on drawing SD/994715/WW/01. The redundant highway spur would be

- removed and the footway along Westerton Walk continued across the gap as part of the proposed development.
- 2.3 To avoid delay, the applicant, the council's Regeneration Service, regards it as essential for stopping up to take place under Section 116 of the Highways Act 1980 in parallel with a planning application rather than under Section 247 of the Town and Country Planning Act 1990 afterwards. One of the conditions of the Department of Health's £1.75million Care and Supported Specialist Housing funding is that the scheme must be completed before 31 March 2018. This timescale is extremely tight so work needs to start on site as soon as planning approval is obtained.

3 Main issues

- 3.1 A section of adopted highway is no longer needed since the closure of the former adult training centre. The area of highway to be stopped up is therefore considered unnecessary in accordance with Section 116 of the Highways Act 1980 and is shown on drawing SD/994715/WW/01.
- An application to the magistrates' court under Section 116 of the Highways Act 1980 is required to stop up the area of adopted highway shown hatched on drawing SD/994715/WW/01.

4 Corporate Considerations

4.1 Consultation and Engagement

- 4.1.1 Ward members have been consulted by a letter and drawing dated 3 March 2016. To date no responses have been received.
- 4.1.2 The City Solicitor will inform the statutory undertakers and emergency services as part of the statutory consultation process of promoting a stopping up order.

4.2 Equality and Diversity / Cohesion and Integration

4.2.1 An equality, diversity, cohesion and integration screening (Appendix B) has been carried out and confirms that a full impact assessment is not required. The proposals will not impact on any equality characteristic more significantly than any other.

4.4.1 The applicant has agreed to cover the costs incurred in promoting the stopping up order. The estimated cost is £3000 plus the advertising costs which will be approximately £800.

4.5.1 The applicant has agreed to meet the costs, if any, which may be incurred by statutory undertakers exercising their rights under Section 116 of the Highways Act 1980 to recover from the council the cost of removing, diverting or abandoning any equipment located in, on, over, along or across the highway(s) affected by an order granted under Section 116.

5.1 The area of adopted highway comprising the access to the former adult training centre in Westerton Walk, Tingley, is considered to be unnecessary in accordance with Section 116 of the Highways Act 1980.
