# 2. Please provide a brief description of what you are screening

#### Main aim

- 1. As a consequence of the increasing birth rate in Leeds, it is necessary to provide extra modular accommodation at approximately 9 Primary Schools in Leeds as part of the 2016 Bulge Programme. The expansion to provision at these Primary Schools is planned to be available from September 2016.
- 2. These Schemes will be completed under the City Council's Learning Places 2016 Bulge Programme which aims to ensure its statutory duties are met with respect to ensuring a school place for every child within the city and was approved by Executive Board in December 2014.
- 3. The proposal for the extension to these schools forms part of the on-going work to address capacity and sufficiency across all of Children's Services, which includes provision for primary and secondary school places, early years, as well as specialist provision. These proposals form part of the Council's Learning Places Programme that embeds the 'one council' approach that has achieved shared ownership of proposed solutions.

4. A total of 9 school sites are currently identified as requiring additional modular accommodation to allow an extra intake of pupils (bulge) from September 2016, based on pupil numbers and demographic predictions.

The school governing body will be regularly updated on progress and allowed to feedback with comments on an ad hoc, upon request basis.
