- 3.1 The following guidance notes are proposed to be removed from the Constitution
 - Memorandum of understanding between the Executive Board and Overview and Scrutiny
 - Protocol between Scrutiny and the Community Safety Partnership in Leeds
 - Protocol for the Yorkshire and Humber Councils joint Health Scrutiny Committee
- 3.2 The removal of the above guidance notes would result in no guidance notes being contained within the constitution. The Scrutiny Board Procedure Rules and the Articles in the Constitution make adequate reference to the processes to be undertaken by a Scrutiny Board in carrying out its functions.
- 3.3 Given the proximity of the annual meeting of Council and the subsequent republication of the Council's constitution it is proposed that the guidance notes are removed with effect from 19th May 2016 (the date of the annual meeting.)
