Summary of main issues

Following an annual review of the Constitution amendments have been made, interalia by resolution at the Annual Council Meeting to the Council Procedure Rules.

Proposals set out in this report recommend amendments to the Constitution consequential upon those amendments to give effect to that decision of Council.

Recommendations

With effect from the 20th May 2016 the Head of Governance Services is requested to make amendments to:-

- The Officer Delegation Scheme (Council (non executive) Functions City Solicitor, as shown in Appendix A attached; and
- the Scrutiny Board Procedure Rules, as shown in Appendix B attached

for the reasons set out in this report.

1 Purpose of this report

1.1 This report sets out proposed amendments to the Constitution to give effect to a decision of Council.

2 Background information

- 2.1 Article 15.2 makes provision for amendments to be made to the constitution. In addition to the specific power to amend those documents in respect of which she has specific delegated authority (as shown in the front sheet to each document) the Monitoring Officer is authorised to make any changes to any part of the Constitution which are required:
 - As a result of legislative change or decisions of the Council or Executive in order to maintain it up to date;
 - Or for the purposes of clarification only.
- 2.2 The Monitoring Officer has delegated authority in this regard to the Deputy Monitoring Officer.

3 Main issues

- 3.1 Officer Delegation Scheme (Council (non-executive) Functions City Solicitor
- 3.2 By her delegated decision dated 9th May 2016 following the annual review of the constitution, the City Solicitor amended constitution document 2A "Functions of the Full Council" to show the change in appointment of Deputy Electoral Registration Officer from City Solicitor to Assistant Chief Executive (Citizens and Communities).
- 3.3 It is recommended that the City Solicitor's council delegations are now amended, as shown at Appendix A attached, to show that she is no longer appointed as Deputy Electoral Registration Officer.
- 3.4 Scrutiny Board Procedure Rules
- 3.5 Amendments to the Council Procedure Rules, approved by Full Council by resolution at the Annual Council Meeting, make provision for the appointment of substitute Members for the Council's Overview and Scrutiny Committees.
- Given that arrangements for substitutes are now made in accordance with the Council Procedure Rules the provision in paragraph 4.2 of the Scrutiny Board Procedure Rules is now redundant and it is therefore recommended that this provision is removed. The recommended amendment is shown at Appendix B attached.
