Summary of main issues

- 1. Planning permission for the demolition of existing buildings, the refurbishment and extension of an existing building and development of two new buildings to provide key worker housing, student accommodation, private market apartments and two commercial units on Belle Vue Road and St John's Road was granted in September 2014 (reference number 13/04862/FU).
- 2. The redevelopment of the site requires the amendment of existing waiting and loading restrictions to control on-street parking and to ensure the safety and free-flow for all Highway users within the vicinity of the development.
- 3. To ensure the standard and specification of any necessary Highway Works, the Developer will need to enter into a Mini Section 278 Agreement with Leeds City Council, prior to undertaking any works on the Highway.

Recommendations

- 4. The Chief Officer (Highways and Transportation) is requested to:
 - i) note and approve the proposed TRO amendments as outlined in Section 3 and indicated on drawings referenced: 278190-LCC-HWT-XX-DR-EP-01_03_ and 278190-LCC-HWT-XX-DR-EP-01_04 , at an estimated cost of £6,000;
 - ii) instruct the City Solicitor to advertise a draft Traffic Regulation Order in relation to the waiting restrictions as indicated on drawing referenced: 278190-LCC-

- HWT-XX-DR-EP-01_03_ and 278190-LCC-HWT-XX-DR-EP-01_04_, and, if no valid objections are received then make, seal and implement the Order; and
- iii) give authority to enter an agreement with the Developer under provision of Section 278 of the Highways Act 1980 for the provision of new vehicular accesses with associated footway works and the reinstatement of redundant accesses to full footway construction on Belle Vue Road and St John's Road, Hyde Park, with associated staff fees of £2,500.

1 Purpose of this report

1.1 This report seeks the authority for the amendment of existing waiting and loading restrictions along Belle Vue Road and St John's Road, Hyde Park, and the authority to enter into a Mini Section 278 Agreement with the Developer. The total estimated staff fees associated with the Mini Section 278 Agreement and the Traffic Regulation Order is £8.500.

2 Background information

- 2.1 Planning permission for the demolition of existing buildings, the refurbishment and extension of an existing building and development of two new buildings to provide key worker housing, student accommodation, private market apartments and two commercial units on Belle Vue Road and St John's Road was granted in September 2014 (reference number 13/04862/FU).
- 2.2The redevelopment of the site requires the amendment of existing waiting and loading restrictions to control on-street parking and to ensure the safety and free-flow for all Highway users within the vicinity of the development.

3 Main issues

- 3.1 The Highway Works will consist of the following:
- 3.2 The removal of 'Parking for Police Vehicles only' restrictions on Belle Vue Road and St John's Road, as indicated on drawing referenced: 278190-LCC-HWT-XX-DR-EP-01 03, due to the redevelopment of the former police station.
- 3.3 The introduction of a 'Loading Bay for Good Vehicles only' restriction on Belle Vue Road, as indicated on drawing referenced: 278190-LCC-HWT-XX-DR-EP-01_03_.
- 3.4 The introduction of a 'Parking for Vehicles Displaying a Disabled Persons Badge only' restriction on St John's Road, as indicated on drawing referenced: 278190-LCC-HWT-XX-DR-EP-01_03_.
- 3.5 The introduction of 'No Waiting At Any Time' restrictions on St John's Road, as indicated on drawings referenced: 278190-LCC-HWT-XX-DR-EP-01_03_ and 278190-LCC-HWT-XX-DR-EP-01_04_.
- 3.6 The physical works required to implement the proposed restrictions will be carried out by the Developer.

- 3.7 The Developer will need to enter into a Mini Section 278 Agreement with Leeds City Council to ensure the Highway Works are constructed to Highway Authority requirements.
- 3.8 The Mini Section 278 Agreement is currently being progressed and the Developer has already paid the staff fees of £2,500 associated with the Agreement.

4 Corporate Considerations

4.1 Consultation and Engagement

- 4.1.1 Relevant sections in Highways and Transportation have been consulted and their comments have been incorporated where possible.
- 4.1.2 The Emergency Services and Metro were consulted on 11th March 2016. No issues were raised with the proposals.
- 4.1.3 Ward Members of Hyde Park and Woodhouse, along with local businesses and residents were consulted on 11th March 2016. No issues were raised concerning the proposals. Two Ward Members responded stating that they had no issues with the works, and one Ward Member did not respond.

4.2 Equality and Diversity / Cohesion and Integration

- 4.2.1 A screening document (Appendix 1) has been prepared and has identified that there is no requirement to carry out an independent impact assessment on the proposals requested.
- 4.2.2 Crossing points will be provided for pedestrians, as part of the Mini Section 278 Agreement works, where the desire to cross exists and where suitable provision has been specifically provided. These measures provide a safer environment for all pedestrians, especially parents with young children, blind and visually impaired people, wheelchair users, people with mobility issues and the infirm.
- 4.2.3 2 disabled parking bays will be created at the location of existing parking bays for police vehicles only, which are no longer needed due to the redevelopment of the former police station. This will provide a better environment for disabled people as it ensures they will be able to use a parking place near to the entrance of the development and they will not have to walk to a parking space further along St John's Road.
- 4.2.4 One negative impact of the proposals is that a length of time-restricted parking bays will be removed and replaced with "No Waiting At Any Time" restrictions at the location of a new vehicular access. This reduces the number of vehicles that will be able to use this length of time-restricted parking bays and could increase the journey times for road-users who originally would have used the existing parking bays.
- 4.2.5 The negative impact is mitigated against by providing adequate visibility for vehicles using the new vehicular access, thus maintaining highway safety. Also, the removal of a length of time-restricted parking bays only results in space for approximately 5

vehicles to park being lost. As part of the new development, 141 parking spaces will be provided for the users of the development. This mitigates against the loss in time-restricted parking bays.

4.3 Council policies and City Priorities

4.3.1 The proposed TRO amendments accord with the Council's Local Transport Plan and other policies in that they provide a safe means of access for all users of the Highway, to and around, the development.

4.4 Resources and value for money

- 4.4.1 The total estimated cost of the scheme is £8,500, comprising £6,000 Traffic Regulation Order costs and £2,500 staff fees.
- 4.4.2 The scheme will be fully funded by the Developer through Mini Section 278 revenue receipts.

4.5 Legal Implications, Access to Information and Call In

4.5.1 The works are exempt from call in being a consequence of and in pursuance of a regulatory decision.

4.6 Risk Management

4.6.1 The Council's standard Mini Section 278 Agreement will be used whereby the developer will fund the total cost of the works, including the cost of introducing the proposed TRO amendments.

5 Conclusions

5.1 This report seeks authority to promote amendments to an existing TRO and authority to enter into a Mini Section 278 Agreement for a new commercial and residential development.

6 Recommendations

- 6.1 The Chief Officer (Highways and Transportation) is requested to:
 - i) note and approve the proposed TRO amendments as outlined in Section 3 and indicated on drawings referenced: 278190-LCC-HWT-XX-DR-EP-01_03_ and 278190-LCC-HWT-XX-DR-EP-01_04_, at an estimated cost of £6,000;
 - ii) instruct the City Solicitor to advertise a draft Traffic Regulation Order in relation to the waiting restrictions as indicated on drawing referenced: 278190-LCC-HWT-XX-DR-EP-01_03_ and 278190-LCC-HWT-XX-DR-EP-01_04_, and, if no valid objections are received then make, seal and implement the Order; and
 - iii) give authority to enter an agreement with the Developer under provision of Section 278 of the Highways Act 1980 for the provision of new vehicular accesses with associated footway works and the reinstatement of redundant

accesses to full footway construction on Belle Vue Road and St John's Road, Hyde Park, with associated staff fees of £2,500.

Negative Impacts:
