

A food growing group has been established since 2015 on land at back Cautley Road, Cross Green.</p> <p>The Director of Environment & Housing agrees to release £18,000 for the Cross Green Food Growing Utilities project and £15,000 for the Back Cautley Road fencing project and grants authority to spend from parent scheme number 16500/BEI/000 during 2016/17.</p>
