Currently in Leeds; white British females aged between 14 and 16 years old are over represented in terms of identification of young people at risk of or experiencing child sexual exploitation. There are a number of interconnecting reasons for this; both locally and nationally. High quality appropriate training for professionals will help to address raising awareness of this issue, and highlight the fact that all children, regardless of background, race, ethnicity and gender are at risk of being exploited.

The issue of Child Sexual Exploitation is an emotive one. Media reports often skew perceptions of both the victims and perpetrators of CSE for example that it is white girls that are exploited by groups of Asian males. The proposed training will aim to provide an evidence based perspective of the picture in Leeds and nationally, which should have a positive impact on access to services by a wider, more equal, representation of young people.

The training will aim to bust myths relating to Child Sexual Exploitation and support staff to challenge misconceptions that may act as a barrier to services for vulnerable young people.
