#### Summary of main issues

- 1. At the Annual Meeting of Council on 19<sup>th</sup> May 2016, the Leader presented details of her Executive Arrangements to Council.
- 2. Amendments have been made by the Leader to those arrangements to provide greater clarity around the Portfolio for Environment and Sustainability, and to rectify an erroneous removal of an authorisation for the City Solicitor in relation to indemnities.

# 1 Purpose of this report

1.1 This report sets out amendments made to the Leader's executive arrangements to ensure that they remain up to date and fit for purpose.

## 2 Background information

- 2.1 At the Annual Meeting of Council on 19<sup>th</sup> May 2016 the Leader presented her executive arrangements for the 2016/17 municipal year.
- 2.2 Rule 1.3 of the Executive and Decision Making Procedure Rules provides that

"The Leader may amend the scheme of delegation relating to executive functions at any time during the year... The amendments will take effect upon publication of the decision notice unless otherwise stated thereon. The Leader will present a report to the next ordinary meeting of the Council setting out the changes made by the Leader."

2.3 The Leader made these amendments on 4<sup>th</sup> August 2016 and, in accordance with the Executive and Decision Making Procedure Rule provisions detailed above, are now reported by way of this report to Full Council

## 3 Main issues

## Environment and Sustainability

- 3.1 The Leader created a new portfolio for Environment and Sustainability in the 2016/17 municipal year. In order to provide clarity to the remit of the portfolio amendments have been made to the Executive Members Oversight of Officer Executive Delegations (Appendix A) and the Officer Delegation Scheme (Executive Functions) Director of Environment and Housing (Appendix B).
- 3.2 Indemnities
- 3.3 A review of the Constitution in 2014 prompted the reduction of detailed general delegations to officers in relation to financial and procurement functions. It has become clear that the City Solicitor's authority to issue indemnities to Directors in relation to their provision of certificates under the Local Government (Contracts) Act 1997 or their activities as a director of the LEP or LIFTco. In order to make good this erroneous deletion of the function the Leader has agreed amendments to the Officer Delegation Scheme (Executive Functions) City Solicitor (Appendix C).
