b) The prevention of crime and disorder

BY SUPERVISION SUPPLEMENTED BY NOTICES SUPPLIED BY THE POLICE. ADMISSION TO THE CLUB IS RESTRICTED TO MEMBERS AND THIER BONA FIDE GUESTS. VISITING CRICKET TEAMS, SNOOKER TEAMS AND DARTS AND DOMINOES TEAMS ARE INTRODUCED TO THE CLUB AS THE CLUB'S GUESTS. REPORTED MISCONDUCT WILL BE DEALT WITH BY THE MANAGEMENT COMMITTEE IN ACCORDANCE WITH RULES.

c) Public safety

RISK ASSESSMENT WILL BE UNDERTAKEN IN ALL PARTS OF THE CLUB FOR ALL EVENTUALITIES. THESE WILL BE REVIEWED ANNUALLY. PAT TESTING OF ELECTRICAL EQUIPMENT WILL BE CONDUCTED ANNUALLY. FIRE FIGHTINF EQUIPMENT WILL BE TESTED AND SERVICED ANNUALLY. EMERGENCY EXITS ARE SIGN POSTED. WEEKLY CHECKS ARE MADE FOR HAZARDS, EMERGENCY LIGHTS WILL BE CHECKED WEEKLY AND SPILLAGES WILL BE PROMPTLY DEALT WITH. DAILY CHECKS WILL BE MADE TO ENSURE EASE OF ENTRY AND EXIT AT ALL DOORS.

d) The prevention of public nuisance

THE CLUB WILL NOT PLAY LIVE MUSIC. THE CLUB WILL COMPLY WITH ADVISED CAPACITY LIMITS. NOTICES WITHIN THE CLUB WILL REMIND MEMBERS TO LEAVE QUIETLY.

e) The protection of children from harm

THE CLUB WILL INSIST ON PARENTS OR GUARDIANS ACCOMPANYING CHILDREN AT ALL TIMES. COMMITTEE MEMBERS WILL CONTROL ALL ACTIVITIES; CHILDREN WILL NOT BE SERVED AT THE BAR, PARENTS WILL MAKE THEIR PURCHASES. THE CLUB HAS A CHILD PROTECTION POLICY IN PLACE.
