Approval to appoint to Creative Space Consultancy to carry out an assessment for the viability of Phase 2 proposals for Assisted Living Leeds to a value of £20,000.

The assessment is likely to be a resource intensive activity, requiring specialist skills to outline the viability of Phase 2 proposals. The assessment will undertake the following:

- Identify unmet demand and market opportunity for assisted living products and technology
- Assess and identify future needs for assistive technology within the Leeds population
- Draw on best practice in delivering of AT services from elsewhere in the UK, (extensive research on AT service examples from the UK will be provided by ASC) Europe and worldwide

- Assess the viability and provide relevant data to support ASC's production of a detailed business case for the move to new premises with partners and the ALL2 proposals
- Assist LCC in the assessment of the Innovation Lab concept and its viability
