#### **The Report requests**

The Director of Environment and Housing is requested to suspend lettings, remove from charge and demolish 6 garages and associated structures and debris at Summerfield Gardens, Bramley. Garage reference numbers GB1 to GB6. The garages are a source of anti-social behaviour and Ward Members and the local community are supportive of demolition. The site is currently being considered by City Development in terms of marketing options but is not suitable for an affordable housing site. The garages are in a serious state of disrepair and contain asbestos. They are beyond refurbishment and there is limited demand in the area for garages.
