Summary of main issues

To declare an area of adopted highway comprising a spur off Brayton Green, Swarcliffe unnecessary in accordance with Section 116 of the Highways Act 1980.

Recommendations

The Chief Officer (Highways and Transportation) is requested to instruct the City Solicitor to apply to the Magistrates' Court for a Stopping Up Order under the provisions of Section 116 of the Highways Act 1980 for the area of adopted highway shown hatched on drawing SD/217960/BG/01 (Appendix A).

1. Purpose of this report

1.1 To seek approval to promote a stopping up order for an area of adopted highway, comprising a spur off Brayton Green, Swarcliffe.

2 Background information

2.1 Brayton Green is situated in Swarcliffe, approximately 7km north east of Leeds City Centre. The spur to be stopped up originally served an old people's home at the corner of swarcliffe Avenue and Brayton Green which was demolished in 2003. The site is now vacant and the council intends to sell it for development as a doctors' surgery.

- 2.2 The access next to 35 Brayton Green is no longer needed and, as it is adopted highway, it will have to be legally stopped up. The area area of highway to be stopped up, approximately 11 square metres, is shown hatched on Drawing SD/217960/BG/01.
- 2.3 The redundant highway spur has aleady been removed and the footway along Brayton Green continued across the gap. Stopping up under Section 116 of the Highways Act 1980 is needed rather than under Section 247 of the Town and Country Planning Act 1990 because the work has already taken place and would not therefore be needed to implement a planning consent.

3 Main issues

- 3.1 A section of adopted highway is no longer needed since the demolition of former buildings on the site. The area of highway to be stopped up is therefore considered unnecessary in accordance with Section 116 of the Highways Act 1980 and is shown hatched on Drawing SD/217960/BG/01.
- An application to the magistrates' court under Section 116 of the Highways Act 1980 is required to stop up the area of adopted highway shown hatched on Drawing SD/217960/BG/01.

4 Corporate Considerations

4.1 Consultation and Engagement

- 4.1.1 Ward members have been consulted by a letter and drawing dated 31 May 2016. No responses have been received.
- 4.1.2 The City Solicitor will inform the statutory undertakers and emergency services as part of the statutory consultation process of promoting a stopping up order.

4.2 Equality and Diversity / Cohesion and Integration

4.2.1 An equality, diversity, cohesion and integration screening (Appendix B) has been carried out and confirms that a full impact assessment is not required. The proposals will not impact on any equality characteristic more significantly than any other.

4.4.1 The applicant has agreed to cover the costs incurred in promoting the stopping up order. The estimated cost is £3,000 plus the advertising costs which will be approximately £800.

4.5.1 The applicant has agreed to meet the costs, if any, which may be incurred by statutory undertakers exercising their rights under Section 116 of the Highways Act 1980 to recover from the council the cost of removing, diverting or abandoning any equipment located in, on, over, along or across the highway(s) affected by an order granted under Section 116.

5 Conclusions

5.1 The area of adopted highway comprising the access to vacant land on the corner of Swarcliffe Avenue and Brayton Green, Swarcliffe, is considered to be unnecessary in accordance with Section 116 of the Highways Act 1980.

6 Recommendations

6.1 The Chief Officer (Highways and Transportation) is requested to instruct the City Solicitor to apply to the magistrates' court for a stopping up order under the provisions of Section 116 of the Highways Act 1980 for the area of adopted highway shown hatched on Drawing SD/217960/BG/01.
