The proposal is to review the air quality management areas (AQMA's) currently declared within Leeds with a view to declaring two new AQMA's and removing two areas from the AQMA regime. An AQMA identifies a relatively small geographical area as having poor air quality and places an obligation on the council to introduce an action plan to improve local air quality.

There is clear evidence that confirms some specific groups are disproportionately affected by Air Quality issues, such as disabled people (asthma/COPD), elderly people (poorer immune systems and less reserve) and pregnant women (low birth weight babies and increased maternal complications). The recommendations contained in the Executive Board report have been designed with the intention of delivering tangible

outcomes that will improve air quality in Leeds, and consequentially improve conditions for the afore mentioned groups.

As part of the review process a public consultation exercise was undertaken to invite the views and comments of all residents and businesses within and adjacent to the AQMA's in scope. In addition the views of Ward Members was actively sought. All views and comments are included as an appendix in the report.
