contract with Esendex Limited for the provision of a bulk SMS messaging

service.

## **Summary of main issues**

- The Council's has in place a contract with Esendex Limited for the provision of a bulk SMS messaging service, which expires 9th December 2016.
- 2. There is a requirement to continue the provision of a service to send bulk SMS messages across the Council.
- 3. The current service has been integrated with systems and procedures within the Council

#### Recommendations

4. The Chief Digital Officer is recommended to approve the waiver of Contract Procedure Rules 8.1 and 8.2 and enter into a 1 (one) year contract with Esendex limited for the provision of a bulk SMS messaging service.

# 1 Purpose of this report

1.1 This report seeks approval from the Chief Digital Officer to waive Contract Procedure Rules 8.1 and 8.2 and enter into a contract with Esendex Limted for the provision of a bulk SMS messaging service for a period of 1 (one) year.

# 2 Background information

- 2.1 The existing contract with Esendex Limited for the provision of a bulk SMS messaging services expires on 9th December 2016.
- 2.2 There is a requirement to continue to provide the bulk SMS messaging service.

#### 3 Main issues

- 3.1 The Council has integrated a number of systems and procedures with the current service from Esendex Limited.
- 3.2 Should a contract not be awarded, the Council would be unable to continue to provide a bulk SMS messaging service currently available to directorates.
- 3.3 The Council hold a number of short and long number SMS accounts with Esendex which are used in the community and displayed on literature. Work is being undertaken during the next 12 months to understand the resource and costs involved in changing these numbers.
- 3.4 Work is currently underway to internally develop a simple application which will provide the functionality required to compose and send texts reducing the need for an external provider.
- 3.5 The cost of similar services offered by other providers via the G-Cloud agreement is cheaper but considering the additional resource/cost to change providers, it is not believed the Council would obtain value for money by conducting a procurement exercise.

### 4 Corporate Considerations

## 4.1 Consultation and Engagement

4.1.1 The Service owner has been consulted and this report reflects the continuing requirements of a bulk SMS messaging service.

### 4.2 Equality and Diversity / Cohesion and Integration

4.2.1 There are no Equality and Diversity / Cohesion and Integration issues associated with this decision.

#### 4.3 Council Policies and City Priorities

4.3.1 The service underpins directorates requirements to meet the City Priorities by providing for the bulk notification by SMS text messaging to members of the public.

#### 4.4 Resources and Value for Money

4.5 The cost of similar services offered by other providers via the G-Cloud agreement is cheaper but considering the additional resource/cost to change providers and change the short and long number accounts currently in use, it is not believed the Council would obtain value for money by conducting a procurement exercise at this stage.

4.5.1 The fixed cost of the service is £16,320 per annum, with per-usage charges expected to be in the range of £1000 to £2500 throughout the duration of the on year agreement.

### 4.6 Legal Implications, Access to Information and Call In

- 4.6.1 The value of the service does not fall within the scope of the Public Contract Regulations.
- 4.6.2 The award value is an administrative decision and the waiver of the Contract Procedure Rules is a Significant Operational Decision.

## 4.7 Risk Management

4.7.1 The contract will be managed by the contract manager through review meetings.

#### 5 Conclusions

To ensure the continued provision of a bulk SMS messaging service and avoid the financial and resource costs associated with moving provider the contract should be awarded to Esendex Limited.

#### 6 Recommendations

The Chief Digital Officer is recommended to approve the waiver of Contract Procedure Rules 8.1 and 8.2 and enter into a contract with Esendex limited for the provision of a bulk SMS messaging service.
