# Summary of main issues

- 1 Outline Planning permission 13/03051/OT was granted on 2<sup>nd</sup> April 2015 for the development of 325 dwellings by Bellway Homes on a site located at the A661 Spofforth Hill, Wetherby. A location plan is attached at **Appendix 2**.
- 2 The off-site highway works are described in detail in para 6.2 below and briefly comprise a scheme of Gateway featues on the approach to the new site entrance along the A661 (from the direction of Harrogate); a signalised pedestrian crossing on Spofforth Hill and a new section of footway to provide a pedestrian connection to the crossing from the nearby Chatsworth Drive.
- 2.1 At the planning stage, the City Plans Panel Members were advised that a Ghost Island would be the Highway Authoritys preferred means of access, but was not essential, to serve the proposed development. This recommendation was provided by highway officers after taking account of the guidance in both DMRB TD42/95 and Manual for Streets 2.
- 3 To meet the requirements of the planning permission and deliver the highway alterations, the applicant has requested that Leeds City Council, as Highway Authority, enters into a Section 278 Agreement to enable the highway works to be carried out.

# **Best City Ambition**

4 The Best City ambition is to improve life for the people of Leeds and make our city a better place. The provision of improvements to Spofforth Hill by the introduction of Gateway features and a signal controlled pedestrian crossing contributes to this ambition by improving the safety and quality of life of Leeds residents by enabling safe pedestrian, cycling and vehicular journeys in local communities.

# Recommendations

- 5 The Chief Officer (Highways and Transportation) is requested to:
  - i) note the principles of the highway works as outlined in Section 6.2 and shown on Drawing Numbers 7029/020 Rev C and 7029/021 Rev C as shown at **Appendix 3** of this report;
  - ii) give authority to negotiate the terms of and enter into an agreement with the developer under the provisions of Section 278 of the Highways Act 1980; whereby the works associated with the development are carried out by this Council at the cost of the developer;
  - iii) give authority to incur expenditure of £53,000 works costs, excluding any statutory undertakers costs; and £20,000 staff fees to be fully funded by the developer through the S278 Agreement;
  - iv) request the City Solicitor to advertise a notice under Section 23 of the Road Traffic Regulation Act 1984 for the implementation of a formal pedestrian crossing on Spofforth Hill; and
  - v) Give authority to carry out the detailed design, tender and implement the works as set out in Section 6.2.

# 1 Purpose of this report

- 1.1 The purpose of this report is to note the principle of the implementation of highway works associated with the development of 325 dwellings by Bellway Homes at Spofforth Hill, Wetherby.
- 1.2 To obtain authority to negotiate the terms of enter into an Agreement under the provisions of Section 278 of the Highways Act 1980, whereby the associated highway works are carried out by Leeds City Council at the expense of the developer.
- 1.3 To request the City Solicitor to advertise a notice for the implementation of a formal pedestrian crossing in accordance with Section 23 of the Road Traffic Regulation Act 1984.
- 1.4 To give authority to incur expenditure associated with the implementation of highway works associated with the development.

# 2 Background information

- 2.1 Planning permission 13/03051/OT was considered by the City Plans Panel and granted on 2<sup>nd</sup> April 2015. The development consists of 325 dwellings on land at Spofforth Hill, Wetherby. The developer is Bellway Homes.
  - a. Highway works are required to provide satisfactory pedestrian and vehicular access to the development from the local highway network. The highway works are shown indicatively on the attached Drawing Numbers 7029/020 Rev C and 7029/021 Rev C as shown at **Appendix 3** and detailed in Section 6.2. The access proposals were the subject of significant debate at the City Plans Panel, the detail of which is included for information in Section 6 of this report.
  - b. To meet the obligations of the planning permission the applicant has requested that Leeds City Council, as Highway Authority, enters into a Section 278 Agreement to enable the highway works to be carried out.

# 3 Main issues

- 3.1 Bellway Homes have received planning permission (ref: 13/03051/FU) to construct 325 dwellings on a site located at Spofforth Hill, Wetherby.
- 3.2 The planning permission includes a package of highway works on the A661 Spofforth Hill to provide safe and satisfactory pedestrian and vehicular access to the development. The proposed works comprise:
  - a. A scheme of gateway features on the approach to the site on the A661 (from the direction of Harrogate).
  - b. A signalised pedestrian crossing on Spofforth Hill located just north-west of the Chatsworth Drive junction; including a new short section of footway on the southern side of the carriageway, to provide a pedestrian connection from Chatsworth Drive to the new crossing.
  - c. Any works reasonably required following safety audits of the design and construction of the highway works.
  - d. All associated civils works, including (inter alia) reconstruction, tie-ins, resurfacing, lighting, signing, drainage and lining works etc.
  - e. Any associated statutory undertakers' works resulting from the works.
- 3.3 Indicative details of the works are included on Drawing Numbers 7029/020 Rev C and 7029/021 Rev C shown at **Appendix 3**.

# Site Access

3.4 At the planning stage the site access proposals initially included a Ghost Island right turning facility at the site entrance from Spofforth Hill and a length of new footway on the opposite side to provide a segregated pedestrian route for people walking from Leconsfield Court to the new signalised crossing. However, these elements of the works were subsequently removed at the specific request of Members of the City Plans Panel in order to safeguard a number of mature trees and to maintain the existing character of the locality.

- 3.5 Panel Members were advised that the Highway Authority's preference was that a Ghost Island be provided at the site access. This recommendation was given having regard to guidance contained in DMRB TD42/95 and taking account of the existing traffic flows on Spofforth Hill and the traffic expected to be generated by the dwellings served from the new site access.
- 3.6 However, advice in Section 9.4 of Manual for Streets 2 indicates that TD42/95 is written specifically for trunk roads and should not be applied uncritically where used in other situations. Furthermore, it is advised that right turning lanes make it more difficult for pedestrians to cross major roads and lead to higher traffic speeds and authorities should therefore consider carefully all of the effects before deciding to provide them. On balance, after taking account of the guidance in both DMRB TD42/95 and Manual for Streets 2, Panel Members were advised that a Ghost Island would be the Highway Authoritys preferred means of access, but was not essential, to serve the proposed development.
- 3.7 The Members of the City Plans Panel subsequently agreed that the site access should be approved without a Ghost Island but with land safeguarded should it be required following occupation of the houses. The Section 106 agreement for the development therefore includes a clause that, in the event that a Road Safety Audit undertaken within five years of the occupation of the final dwelling demonstrates that a right turning lane is necessary in the interests of highway safety, the developer is required to upgrade the site access junction and carry out the construction of right turning facility at their own expense.

# **Gateway Features**

3.8 The works include the provision of gateway features on the approach to the site on the A661 (from the direction of Harrogate). The stretch of road subject to these works is shown indicatively on drawing 7029/021 Rev C. For the avoidance of doubt the nature of the gateway features will be determined through the detailed design process, the requirement for which will be detailed in a design brief. The nature of the gateway feature will therefore be subject to further consultation and the measures shown on the drawing are not approved.

# Pedestrian Crossing

- 3.9 The scope of the highway works and position of the pedestrian crossing were determined at the time of the outline planning application 13/03051/OT. A reserved matters application for the internal road layout of the development (ref: 15/07291/RM) was approved on 29<sup>th</sup> July 2016 by the City Plans Panel. The optimum location of the pedestrian crossing has been questioned as part of this recent planning application.
- 3.10 Condition 6 of this permission requires a Community Liaison Management Plan to be developed by Bellway Homes which is to consist of a working party involving Wetherby Town Council, Ward Members, any relevant council officers and 2 residents of Spofforth Hill affected by the pedestrian crossing proposals. It is understood that the purpose of the Community Liaison Management Plan is to act

as a forum for communication/dialogue between the developer and the local community during the construction period of the development.

- 3.11 The scope of the highway works and position of the pedestrian crossing were determined at the time of the outline planning application 13/03051/OT. Officers in conjunction with the forum are currently exploring the optimum position of the crossing. It is not anticipated at this stage that the location of the crossing would change. However, should there be any material change to the highway improvements as a result of the community liaison process, a further Design & Cost report will be brought forward to inform of the modifications to the works prior to the signing of the Section 278 agreement.
- 3.12 Section 278 of the Highways Act 1980 allows Highways Authorities to enter into agreements with developers for the execution of highway works at the developer's expense. The preconditions for an agreement under Section 278 of the Highways Act 1980 are, first, that the Highway Authority should be satisfied that it will be of benefit to the public to enter into an agreement for the execution of the works and, secondly, that the work must fall within the Highway Authority's powers of road building, improvement and maintenance.
- 3.13 Safety Audits and Maintenance Audits are to be carried out as part of the detailed design process. The S278 Agreement will ensure that Safety Audits form part of the design process, and any appropriate works arising out of the audits are implemented at the developer's expense.
- 3.14 The S278 agreement will include the standard commuted sums for future maintenance of the works.

# 4 Corporate Considerations

# 4.1 Consultation and Engagement

- 4.1.1 Ward Members: Ward Members were consulted by email dated 1<sup>st</sup> September 2016. At the time of writing no comments have been received from the Ward Members.
- 4.1.2 Emergency Services and WYCA: The Emergency Services and WYCA were consulted via email dated 1<sup>st</sup> September 2016. At the time of writing no comments have been received.
- 4.1.3 Internal consultation has taken place with colleagues in the Highways and Transportation Services. Any substantive comments will be taken into account as part of the detailed design process.

# 4.2 Equality and Diversity / Cohesion and Integration

4.2.1 An EDCI Impact Assessment has been carried out on the Section 278 Process and is attached as **Appendix 1**. The assessment confirmed that individual designs put forward as part of this process, will take into account the needs of each of the equality characteristics and will aim to meet Section 278 (4) which states that "A highway authority shall not enter into an agreement under this section unless they are satisfied that it will be of benefit to the public". As part of the design and construction process further equality screenings and impact assessments will be undertaken as required.

# 4.3 Council policies and City Priorities

4.3.1 The proposed highway works which allow the development to take place accord with the West Yorkshire Local Transport Plan and other policies in that they provide a safe means of access for all users of the highway, to and around, the development.

# 4.4 Resources and value for money

4.4.1 The developer will meet the Council's costs, estimated to be £53,000 works costs, excluding any statutory undertakers costs and £20,000 staff fees all of which will be fully funded through the Section 278 agreement.

- 5.3 The highway works are shown indicatively on the attached Drawing Numbers 7029/020 Rev C and 7029/021 Rev C as shown at **Appendix 3** and detailed in Section 6.2.
- 5.4 To meet the requirements of the planning permission and deliver the highway alterations, the applicant has requested that Leeds City Council, as Highway Authority, enters into a Section 278 Agreement to enable the highway works to be carried out.

S278 agreements can be entered into with an individual, but generally they are made between Developers and the Council.

There are three types of S278 agreements:

# Mini Section 278 Agreements

A Mini Section 278 Agreement is a formal arrangement to enable developers to carry out extremely minor highway works. This type of agreement covers minor footway crossing works, amendments to paving to provide level access, removal and reinstatement of planters, etc where the Developer designs and constructs the works, but provides a bond as surety. Leeds City Council obtains staff fees for checking the design and supervision of the works and fixed legal costs. This type of agreement is very minor in nature and does not include for commuted sums (payments for maintenance).

# Minor Section 278 Agreements

A Minor Section 278 Agreement is a formal arrangement for developers to carry out minor highway works themselves. It follows the same format as a mini S278 agreement but is used for schemes which are slightly more involved than a footway crossing, but not so involved that there is any major requirement for traffic management on a busy road, or likely involvement with statutory undertakers, and the design is not complex in any way. This type of agreement is most often used where the development and highway works are adjacent or make use of the same site, making it very difficult for a separate contractor to be working in the same area, eg re-paving footways, provision of lay-by within a site contractor's working zone. A Minor S278 still requires the provision of a bond but does also allow for the acquisition of commuted sums for maintenance.

# Standard Section 278 Agreements

A Standard Section 278 Agreement is used for all other highway works. The works are designed and supervised by Leeds City Council on behalf of the Developer. This type of agreement is used for most significant off-site highway works associated with planning applications. Standard S278 agreements do not require the provision of a bond as all monies are paid upfront.

# Process Review

When considering the requirements of a planning application that will require a S278 agreement to deliver highway works once consent is granted, a pro-forma is completed which considers the following:

- Accessibility using guidelines laid down in the Manual for Streets and LCC Street Design Guide (which has been the subject of an EIA) consideration is given to; walkers, cyclists, vulnerable road users and impact on services nearby, for example - schools
- Vehicular access safety of this, size of the parking bays
- Internal layout / servicing / bins shared surface issues. Ability to move around safely.
- Parking safety issues, availability of disabled spaces in line with the Unitary Development Plan.
- Travel Plan Availability of public transport
- Off site highways works impacts of the development on the surrounding area e.g. increased traffic flows, do we need a new set of traffic lights.
- Road safety current statistics and impact on these, visibility.
- Planning conditions

These items are considered in terms of the protected characteristics.

S278 (4) states that "A highway authority shall not enter into an agreement under this section unless they are satisfied that it will be of benefit to the public", and any suggested changes are put forward with this in mind.




