# Subject: Request to Waiver of Contract Procedure Rules 8.1 and 8.2 to purchase additions and upgrades to current V-TAS system from I-Comply Ltd without seeking competition.

#### Summary of main issues

- 1 The installation of the current I-Comply V-TAS CCTV system utilised by Urban Traffic Management Control (UTMC) requires upgrading to maintain existing functionality and provide controllable display units for other Highways sections.
- 2 This work can only be done by I-Comply Ltd, who supplied the system used by UTMC and Leeds Watch.
- 3 There will be benefits to Network Management, Flood Risk Management and Traffic sections with access to CCTV images assisting the operation covering incidents and events, remote access via the website will allow officers to respond to emergencies out of hours.

#### Recommendations

4 The Chief Officer Highways and Transportation is requested to approve the waiver of Contract Procedure Rule: 8.1 and 8.2 Intermediate Value Procurement and approve the purchase of V-TAS hardware and software from I-Comply at a cost of £29,100 without seeking competition.

# 1 Purpose of this report

1.1 The purpose of this report is to seek approval from the Chief Officer, Highways and Transportation to waive Contract Procedure Rule 8.1 and 8.2 to purchase of V-TAS hardware and software from I-Comply Ltd.

# 2 Background information

- 2.1 Urban Traffic Management Control (UTMC) shares CCTV cameras with LeedsWatch, who have been using an analogue matrix supplemented with an I-Comply digital system for many years. Following the relocation of the service from Merrion House in 2012, UTMC has utilised an I-Comply V-TAS server at Middleton. Transfer of 22 cameras to an ADSL service has saved around £20,000 per annum (20% of the BT Redcare line rental costs). In addition, using I-Comply has enabled new cameras to be installed on traffic signal equipment using traffic signal wireless/broadband communication at no extra cost.
- 2.2 LeedsWatch will cease using the analogue matric later this year, moving fully onto the I-Comply digital platform. For UTMC to retain visibility of all cameras with full control functionality the existing I-Comply server needs to be enhanced.
- 2.3 Currently Traffic and Network Management have CCTV display screens, which are of limited functionality due to equipment compatibility limitations. The proposal is to upgrade these and replace the current analogue system to Flood Risk Management, enabling all these sections to work more efficiently with greater visibility of the Leeds highway network.
- 2.4 Currently the LCC travel information website, LeedsTravelInfo.com, allows the public to see live CCTV images of 23 cameras in key locations, derived from the analogue matrix. The website is used by some 17,500 people each month. To continue to provide these images in the future requires I-Comply to install some additional software.

# 3 Main issues

# **Reason for Contracts Procedure Rules Waiver**

- 3.1 The current system in operation at Neighbourhood & Housing, Leeds Watch utilises the I-Comply V-TAS system to integrate the various CCTV platforms onto one operator station with this system extended to include the UTMC cameras by adding workstations in the UTMC control room.
- 3.2 Switching to another system is not an option at this time as it would require wholesale changes to the operation of UTMC and Leeds Watch and would not allow the full integration of both users CCTV images which would severely limit the visibility of the Highway network to UTMC and other highway sections.

# Consequences if the proposed action is not approved

3.3 Leeds UTMC would have reduced visibility of the highway network, which would reduce its effectiveness in controlling traffic and dealing with network issues. Other highways sections would not have any visibility of CCTV.

3.4 The public would not be able to see live CCTV images in key locations through the LCC travel information website, LeedsTravelInfo.com.

### 4 Corporate Considerations

#### 4.1 **Consultation and Engagement**

- 4.1.1 This decision is primarily related to the support of service provision within Highways and Transportation so no consultation has taken place with elected members.
- 4.1.2 Colleagues in LeedsWatch (Neighbourhoods and Housing) have been consulted on these proposals.

#### 4.2 Equality and Diversity / Cohesion and Integration

- 4.2.1 An Equality, Diversity, Cohesion and Integration Screening has been prepared (Appendix A) and an independent impact assessment is not required for the approvals requested.
- 4.2.2 The screening process confirmed that the proposals have no impact on any of the equality characteristics.

#### 4.3 **Council policies and City Priorities**

4.3.1 The proposed procurement of this system will allow closer integration of CCTV operation throughout Leeds City Council and reduce future revenue costs with the further use of IP technology for CCTV installations.

#### 4.4 **Resources and value for money**

- 4.4.1 The cost of £29,100 can be funded from the budget that was approved in April 2016 (scheme 32543 UTMC Network Monitoring, £40,000) to be funded from the LTP Transport Policy Programme (100% Government grant funded)
- 4.4.2 The system will allow greater flexibility in the provision of CCTV in the future and reduce the need for expensive fibre circuits.
- 4.4.3 Future revenue savings can be realised with the expansion of IP communications replacing the existing fibre network.

#### 4.5 Legal Implications, Access to Information and Call In

- 4.5.1 The report is not subject to Call In and there are no grounds for treating the contents of this report as confidential with the Council's Access to Information Rules.
- 4.5.2 Awarding contracts directly to suppliers in this way could leave the Council open to a potential claim from other suppliers to whom this contract could be of interest that it has not been wholly transparent. In terms of transparency, it should be noted that case law suggests that the Council should always consider whether contracts of this value could be of interest to suppliers from other EU member states and, if it could, the opportunity should be subjected to a degree of

advertising. It is up to the Council to decide what degree of advertising is appropriate. In particular, consideration should be given to the subject-matter of the contract, its estimated value, the specifics of the sector concerned (size and structure of the market, commercial practices, etc.) and the geographical location of the place of performance.

- 4.5.3 In approving this waiver without subjecting the contract to competition, there is a risk of challenge to the Council from other potential providers that have not been given the chance to tender for this opportunity. It is suggested, due to the matters set out at section 3 above, that the risk of challenge identified in paragraph 4.5.2 is considered low.
- 4.5.4 Although there is no overriding legal obstacle preventing the waiver of CPR 8.1 and 8.2, the above comments should be noted. In making their final decision, the Chief Officer (Highways and Transportation) should be satisfied that the course of action chosen represents best value for money.

#### 4.6 Risk Management

- 4.6.1 The addition of Highways workstations will assist relevant sections in their work in a way that will continue to be efficient if the Leeds UTMC control room is relocated. Removing images from the travel information website would be a loss of service to the public as the website has seen an increase in visitor numbers.
- 4.6.2 There will be no future impact on revenue with this proposal.
- 4.6.3 There remains a risk that a complaint could be raised that the council has not followed reasonable procedures, resulting in a loss of opportunity, which could potentially give rise to an Ombudsman Investigation, however it considered that this risk is low.

#### 5 Conclusions

- 5.1 Upgrading the existing V-TAS CCTV control system is essential to continuing to provide a high level of service by UTMC and other Highways sections and this can only be procured from I-Comply.
- 5.2 This project will allow continued access to CCTV images for Network Management, Flood Risk and Traffic following the outdated COE CCTV server decommissioning later this year.

#### 6 Recommendations

6.1 The Chief Officer Highways and Transportation, is requested to approve the waiver of Contract Procedure Rule: 8.1 and 8.2 Intermediate Value Procurement and approve the purchase of V-TAS hardware and software from I-Comply Ltd at a cost of £29,100 without seeking competition.
