2. Please provide a brief description of what you are screening

This decision relates to the seeking of approval to an extension and vary of contract with Care and Repair for the delivery of Home Adaptations for Independent Living Pilot (9RXF-MZHGWW) for 2 x 6 month periods. This service is commissioned by the Strategy & Commissioning Team within Public Health and its purpose is to support vulnerable older and disabled people in the city maintain independence and safety within their home through the delivery of major & minor adaptations, repairs, and falls prevention assessments.

The decision to extend and vary the contract will ensure the continuation of essential services whilst work is undertaken to review, evaluate and analyse performance, develop future provision and conduct a full procurement exercise.

Due regard has been given to equality in the delivery of these services and this has been considered through contract management and the review process.

Following initial contract award the provider completed an action plan, in which recommendations that were made following a joint strategic review of Care and Repair services, prior to pilot contract, were monitored. The action plan picked up on equality considerations and actions required and will be used to inform the design and future commissioning of these services.

Through the housing related support programme more generally, services are required to demonstrate their ability to deliver 'fair access, equality and diversity' in all aspects of service provision.
