When we find a family for a child looked after (foster care), a great emphasis is placed on matching the child's ethnicity, language, gender, religion, needs and interests. Placements made through this contract will be matched to the highest standard and providers are responsible for recruiting foster carers who are able to meet the needs of the children.

The foster carer family work in partnership with the social worker and child to ensure that the child looked after has a good quality family life, which will include teaching them all about equalities. The foster carer family will have been through a thorough assessment when they became a foster carer and have continuing assessment and training that ensures their values are of the highest standard and they give the greatest attention to promoting equalities.

In addition every Independent Foster Agency is regulated by Ofsted who evaluate the delivery of equalities and through quarterly monitoring, we assess the provider against this. We work in partnership with the provider to improve due regard to equalities.
