Glossary

Neighbourhood Area – the geographical area that the neighbourhood plan will cover.

Neighbourhood Forum – The group that prepares the neighbourhood Plan (in non-parished areas and with a minimum of 21 people).

'Policy Intentions' – an informal document that can set out the vision, objectives, key themes and issues (and highlights evidence needed to support these).

Pre submission Draft Plan – the formal draft plan. This consultation is carried out by the Parish/Town Council or Neighbourhood Forum.

Submission Draft Plan – the revised draft plan following pre-submission consultation. This is formally submitted to the Council who then publicises and arranges examination and referendum.

Examination – an assessment of the draft neighbourhood plan by an independent examiner as to whether the Plan meets the 'basic conditions':

- a. having regard to national policies and advice contained in guidance issued by the Secretary of State it is appropriate to make the neighbourhood plan.
- b. the making of the neighbourhood plan contributes to the achievement of sustainable development.

- c. the making of the neighbourhood plan is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area).d. the making of the neighbourhood plan does not breach, and is otherwise compatible with, EU obligations.
- e. prescribed conditions are met in relation to the plan and prescribed matters have been complied with in connection with the proposal for the neighbourhood plan.

Referendum - Local Planning Authorities have a duty to hold referendum(s) where a neighbourhood plan has a successful examination and they are satisfied that the Plan meets the basic conditions. The question asked is: "Do you want Leeds City Council to use the neighbourhood plan for xxxxx to help it decide planning applications in the neighbourhood area?"
