**Summary of main issues**

- 1 Passenger Transport is commissioned by Children’s and Families and Adults and Health to provide transport for children and young people with statements of special educational needs and disabilities (SEND) and children who are in care of the authority requiring home to school transport, as well as older people and adults with learning difficulties on order they can access day services.
- 2 This is currently managed through a mix of our own in house fleet as well as the utilisation of a framework agreement for Taxi and Private hire providers to support the service. The current Framework agreement and Dynamic Purchasing system ( DPS) were both approved in March 2017 and effective from 1<sup>st</sup> April 2017. There are a total of 27 providers on the two arrangements, all of whom have met various quality checks, have provided assurances on safeguarding and agreed to support the Councils ambition to be a child friendly city and comply with the appropriate clean air legislation.
- 3 From July 2017, the service will be required to call-off from the framework and DPS according to the demand for transport from Children’s and Families and Adult’s and Health.
- 4 Any contracts with a value of each individual call-off (i.e. the order for a journey) which is less than £100k will be processed by staff with appropriate delegated authority as an Administrative decision and managed by the service.
- 5 Any contracts with a value of each individual call-off greater than £100k but less than £250k will be actioned by staff within the appropriate Contract procedure rules (CPR’s) and delegated authority as a Significant Operational decision.

- 6 There are four contracts where it is anticipated the spend will exceed £250k per annum, (based on current demand and future plans) and therefore require a Key Decision:-
  - 6.1 A contract for the supply of Home to school transport for Children with SEND to Hallcliffe school. The contract will be for two years.
  - 6.2 A contract for the supply of Home to school transport for Children with SEND to Springwell West Oaks and Oakwood. The contract will be for one year plus an option to extend for a further one year.
  - 6.3 A contract for the supply of Home to school transport for Children with SEND to Springwell East. The contract will be for one year plus an option to extend for a further one year.
  - 6.4 And a contract for the supply of Home to school transport for Children with SEND to Springwell South. The contract will be for one year plus an option to extend for a further one year.
- 7 All contracts will be awarded on a 80/20 price quality split, with the quality score being carried forward from the original Framework contract let.

## Recommendations

- 1 The Director Resources and Housing is requested to note that procurement from the framework arrangement and DPS for Taxi and Private hire will now commence and that :-
  - 1.1 Call-off contracts with a value of £100k or less will be awarded as and when required from 1<sup>st</sup> July 2017 to 31<sup>st</sup> March 2018 as Administrative Decisions by staff with appropriate delegated authority.
  - 1.2 Call-off contracts with a value greater than £100k, but less than £250k, will be awarded as and when required from 1<sup>st</sup> July 2017 to 31<sup>st</sup> March 2018 as a Significant Operational decision by staff within the appropriate Contract Procedure rules.
  - 1.3 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Hallcliffe**. The approx. value of the contract is £250k per annum and the contract will be for two years.
  - 1.4 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Springwell West Oaks and Oakwood**. The approx..value of the contract is £250k per annum and the contract will be for one year plus an option to extend for a further one year.
  - 1.5 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Springwell East**. The approx..value of the contract is £250k per annum and the contract will be for one year plus an option to extend for a further one year.

- 1.6 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Springwell South**. The approx..value of the contract is £250k per annum and the contract will be for one year plus an option to extend for a further one year.

## 1.0 **Purpose of this report**

- 1.1 To advise the Director Resources and Housing that procurement and the award of call-off contracts from the taxi and private hire framework and DPS will now commence with staff awarding call – off contracts within the spend threshold for Administrative Decisions. Details of the individual call offs will be managed and maintained by the service.
- 1.2 To seek approval to commence procurement and award contracts from the taxi and private hire framework and DPS for contracts within the spend threshold for Significant Operational decisions. Approval will be managed through the appropriate Contract Procedure rules.
- 1.3 To seek approval to commence procurement and award a contract for the supply of transport to Hallcliffe, Springwell West Oaks and Oakwood, Springwell East and Springwell South.

## 2 **Background information**

- 2.1 Passenger transport is commissioned by Children's and Families and Adult's and Health to provide home to school transport for children and young people with special educational needs and disabilities and children who are looked after, as well as adults with learning difficulties in order that they can access day services.
- 2.2 The service is currently provided by a mix of our own in-house fleet as well as the utilisation of a framework agreement and DPS from which a total of 27 taxi and private hire providers are invited to bid for routes as and when required.
- 2.3 The framework contract was awarded in March 2017, and started on 1<sup>st</sup> April 2017.

## 3 **Main issues**

- 3.1 Passenger Transport is required to transport over 3000 customers each day. This is managed through our own in house fleet but also in partnership with Taxi and Private hire providers, who through either a framework agreement or a DPS, are able to support the service with the provision of wheelchair accessible minibuses, standard minibuses, cars, and also some companies are able to supply passenger assistants who support the young child or adult with learning difficulties throughout their journey.
- 3.2 Requests for transport are approved by either Children's and Families or Adult's and Health and can be made throughout the year. That said, the bulk of the tenders are let between July and August as a result of the main SEND home to school contract lets.
- 3.3 All contractors will be invited to tender for individual routes or requests to supply all transport into an establishment. The contracts will be awarded on a 80/20 price quality split, the quality score having been determined as part of the framework award.
- 3.4 The contracts will be let for one to two years depending on the passenger needs, and the route requirements.

3.5 There are no implications for the service or the proposed tenders on the forthcoming decision which will be undertaken by Children's and Families regarding Post 16 transport.

## **4 Corporate Considerations**

### **4.1 Consultation and Engagement**

4.1.1 Consultation with both Children's and Families and Adult's and Health continues throughout the year in order that transport arrangements meet the appropriate requirements and is within the appropriate policy.

4.1.2 The service also works in partnership with the Councils Taxi and Private hire licensing service if there is any licensing or regulation issues with a provider.

### **4.2 Equality and Diversity / Cohesion and Integration**

4.2.1 An Equality, Diversity, Cohesion and Integration screening report was considered for the framework arrangement and a further Equality Impact Assessment is not required for this request.

### **4.3 Council policies and City Priorities**

4.3.1 The proposals within this report will contribute to the continued delivery of an effective Passenger Transport service for Leeds City Council

### **4.4 Resources and value for money**

4.4.1 A framework contract has been let and orders will be placed in accordance with its terms and the Council's Contract Procedure Rules. Competition has been used throughout the process to assure value for money.

### **4.5 Legal Implications, Access to Information and Call In**

4.5.1 The value of the contracts will vary therefore throughout the year, therefore the results of each contract award will be managed by the service in accordance with appropriate CPR's.

### **4.6 Risk Management**

4.6.1 If Passenger transport did not have a framework contract which supports the service in the provision of transport some of the most vulnerable children in Leeds would not access learning establishments and adults with learning difficulties would be unable to access day services.

## **5 Conclusions**

5.1 Passenger Transport is commissioned to provide home to school transport for children and young people and transport for adults with learning difficulties in order they can access day services.

5.2 The service is provided through a mix of an in house fleet and the utilisation of a framework agreement whereby taxi and private hire providers are invited to bid for routes as and when required.

- 5.3 In order to meet the weekly demand call off contracts are tendered and awarded. The value of these will vary but will be less than the £100k threshold and will be managed as Administrative decisions and be managed by the service.
- 5.4 There will be further contracts which are tendered and awarded with a value greater than £100k, but less than £250k. These Significant Operational decisions will be managed through the appropriate CPR's.
- 5.5 There are a further four individual contracts which will be procured and awarded with a value greater than £250k per annum. These relate to the transport to Hallcliffe, Springwell West Oaks and Oakwood, Springwell East and Springwell South.

## 6 Recommendations

- 6.1 The Director Resources and Housing is requested to note that procurement from the framework arrangement and DPS for Taxi and Private hire will now commence and call-off contracts with a value of £100k or less will be awarded as and when required from 1<sup>st</sup> April 2017 to 31<sup>st</sup> March 2018 as Administrative Decisions by staff with appropriate delegated authority.
- 6.2 The Director Resources and Housing is requested to approve the request to call off from the framework arrangement for Taxi and Private hire contracts which are likely to exceed £100k, but less than £250k. These Significant Operational decisions will be managed through the appropriate CPR's.
- 6.3 The Director Resources and Housing is requested to approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Hallcliffe**. The approx. value of the contract is £250k per annum and the contract will be for two years.
- 6.4 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Springwell West Oaks and Oakwood**. The approx..value of the contract is £250k per annum and the contract will be for one year plus an option to extend for a further one year.
- 6.5 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Springwell East**. The approx..value of the contract is £250k per annum and the contract will be for one year plus an option to extend for a further one year.
- 6.6 To approve the decision to commence procurement and award a contract for the provision of Home to school transport for children and young people with special educational needs and disabilities who attend **Springwell South**. The approx..value of the contract is £250k per annum and the contract will be for one year plus an option to extend for a further one year.
