### Summary of main issues

1.1 The main issue for the Council is the associated risks and liabilities associated with being a delivery partner as part of a European Structural Funds (ESIF) business support project.

#### Recommendations

- 1. To approve the role of LCC as delivery partner in the SFWYY project.
- 2. To authorise the signing of the associated partnership agreement with the West Yorkshire Combined Authority (WYCA).
- 3. To instruct officers in the Economic Development team to carry out the duties /responsibilities as specified in the partnership agreement.
- To authorise the establishment of a revenue budget of £577,080 (funded through external funding) over the period 2016-19 as a contribution towards associated LCC staff costs.

### 1. Purpose of this report

- 1.2 To inform the Chief Officer Economy & Regeneration of proposals to deliver Superfast West Yorkshire & York (SFWYY) support to Small/Medium sized enterprises (SMEs) based across West Yorkshire & York through the provision of Superfast Broadband.
- 1.3 To seek approval from the Chief Officer Economy & Regeneration for the Council to enter into a partnership agreement with West Yorkshire Combined Authority (WYCA) to deliver Superfast West Yorkshire & York (SFWYY) support to Small/Medium sized enterprises (SMEs) based across West Yorkshire & York through the provision of Superfast Broadband.

# 2. Background information

- 2.1 The Council acted as Contracting Authority and played the lead LA role in successfully delivering the Phase 1 West Yorkshire Local Broadband programme.
- 2.2 With the first phase of the programme now complete, over 65,000 properties can now experience significant improvements to their broadband speeds. More than £21m of funding was allocated for the programme which has seen high-speed, fibre broadband installed across West Yorkshire.
- 2.3 The second phase of the SFWYY programme will extend coverage of fibre broadband throughout the existing intervention area as well as Kirklees and York. The current £19.5m broadband programme will see a further 27,000 businesses and homes having access to high-speed, fibre broadband installed across West Yorkshire and York.
- 2.4 As requested by WYCA and agreed by the Project Board both Contracts (Phase 1 & 2) with the Supplier (BT Group) were Novated to WYCA on 14 December 2015.
- 2.5 Prior to the Novation the Council was approached by WYCA to continue to provide a team to assist the WYCA Programme manager with Deployment assurance, Communications & marketing and Secretariat service. This was outlined in the West Yorkshire and York Local Broadband Partnership (Phase 2) agreement with was signed by all parties on 2 April 2015 (see 7.1).

#### 3. Main issues

- 3.1 The main issue for the Council in entering into the partnership agreement as a formal delivery partner is the potential liabilities associated with any European Structural Funds (ESIF) agreement.
- 3.2 It is proposed that the Council provides the service described in 2.5 on a direct cost basis. It is not proposed that indirect overheads are recovered.

#### 4 Corporate considerations

#### 4.1 Consultation and engagement

4.1.1 The Council's approach to ESIF was discussed on the 28<sup>th</sup> February 2017 with the Corporate Leadership team (CLT). CLT indicated that it was fully supportive of the Council playing an active role in delivering ESIF projects across the City Region. This project forms part of a much wider picture of the Council actively engaging with

ESIF and partners across the City Region to deliver a range of economic development projects to support businesses and invest in essential infrastructure to fuel future economic growth.

## 4.2 Equality and diversity / cohesion and integration

4.2.1 The proposed project will be available to established SMEs across the City Region. Certain sectors are excluded due to ESIF funding rules e.g. primary agriculture, banking /financial services and businesses who primarily trade with consumers.

# 4.3 Council policies and best council plan

4.3.1 In improving business competitiveness and digital inclusion the SFWYY project is consistent with a number of themes in the Best Council Plan 2015-20.

## 4.4 Resources and value for money

4.4.1 The agreement with WYCA provides an income to LCC of £577,080 over the period 2016 to 2019 as a contribution towards LCC staff costs.

## 4.5 Legal implications, access to information, and call-in

4.5.1 Signing this agreement is a significant operational decision (not subject to call-in), as the average spend per Council financial year is forecast to be less than £250,000 per annum.

## 4.6 Risk management

- 4.6.1 Risks associated with the ESIF agreement have been mitigated by clearly defining LCC roles/responsibilities and ensuring that WYCA is responsible for final assurance as Contracting Authority & Accountable Body to grant funding partners for this project.
- 4.6.2 Both parties are able to terminate this agreement by giving a 90 day notice period. This protects the Council in the event that the Council is unable to continue to provide services.

## Conclusions

- 5.1 The SFWYY project improves business competitiveness and helps the city region to become more resilient by reducing the business carbon footprint.
- 5.2 As previously demonstrated through the successful deliver of Phase 1 of the Superfast Project the Economic Development Service has the expertise to provide an effective assurance service and has extensive experience of dealing with ESIF compliance related issues. The project complements other business grants and ESIF business support activities run by LCC.

#### 6. Recommendations

6.1 To approve the role of LCC as delivery partner in the SFWYY project.

- 6.2 To authorise the signing of the associated partnership agreement with the West Yorkshire Combined Authority (WYCA).
- 6.3 To instruct officers in the Economic Development team to carry out the duties /responsibilities as specified in the partnership agreement.
- 6.4 To authorise the establishment of a revenue budget of £577,080 (funded through external funding) over the period 2016-19 as a contribution towards associated LCC staff costs.
