2. Please provide a brief description of what you are screening

The Director of Resources and Housing is being requested to authorise the suspension of lettings, demolition of garages and removal from charge of the 4 council owned garages (G28 to G31) at Weston Park View, Otley LS21 2DU. These garages are part of a larger garage site of 35 garages. The block of 4 garages have been empty for some time and deemed beyond economic repair due to significant vandalism to their structure. The condition of the wider garage site is poor but the 4 garages requested for demolition are in the worst condition. Currently 25 garages are rented across the whole site and 10 are void (including the 4 requested for demolition). The garages are at risk of further deterioration due to sustained vandalism from local children and create the potential for further anti-social behaviour which local residents are very concerned about. The 4 garages are a blight on the wider garage site which is being considered further in terms of the future of the site. Residents and Ward Members support the demolition of these 4 garages. The structures have been

further vandalised this weekend (1/2nd July 2017) and the roof is now collapsing posing a significant risk to the Council therefore emergency demolition is proposed to take place on 5th Jul 2017. Following demolition the area will be tarmacked and it will increase visibility across the wider site which it is hoped may reduce the potential for further anti social behaviour.

Consultation on the proposal took place in June 2017 where residents and Ward Members raised their concerns about the condition of the garages and their negative impact on the area. They therefore fully support the demolition and removal of these four garages and for the area to be tarmacked.

Key findings

The garages are a constant source for anti-social behaviour by local youths which is impacting on local residents many of whom and elderly and potentially vulnerable which is having a negative impact on community cohesion. The demolition and removal of these structures will positively impact on the community. Following demolition of garages the area will be tarmacked. The removal of garages will improve the visibility of the site from both sides of the roads and remove the current hiding place where youths congregate. The garages 4 garages recommended for demolition have been further vandalised and the roof is in danger of collapse.

Actions

Removal of the 4 garages will have positive effect on other garages by improving visibility across the remaining site making it more secure and safe. This decision is supported by Housing Management who confirm that the removal of 4 garages will help reduce antisocial behaviour and disturbance for local residents.

Consideration of the site has been discussed with relevant internal council departments

to determine any future development potential. This currently being explored further and will need to be consulted with Ward Members and Residents in due course once more information is available.

As the garages have not been occupied for some time there is no displacement of any tenancies and removal of these garages may help to improve letting ability of the remaining voids on the garage site.
