

# Consultation on Local Lettings Policy for New Build in Garnet Place & Garnet Terrace, Leeds 11.

# Report of findings – October 2017

### 1 Introduction

Leeds City Council is building 25 new houses in LS11. There will be 18 x 2 bed houses and 7 x 3 bed houses in City & Hunslet ward, these new homes are due to be handed over in early 2018. The consultation to collect the views and opinions from current and prospective tenants about the local lettings policy for these properties was completed in September 2017 using a survey questionnaire. Housing Leeds sent out the survey to 197 applicants on the Leeds Homes Register who had specified City & Hunslet ward as their area of first choice. The questionnaire was also made available at Dewsbury Road One Stop Centre.

### 2 Survey Sample

61 tenants and residents completed the consultation questionnaire (49 responded to the posted questionnaire, 12 of the responses originated from Dewsbury Road OSC). 68% of respondents live in the LS10 & LS11 area. The full breakdown of responses is detailed below.


### 3 Report Findings

The consultation has found that respondents feel that preference for housing offers should be given to Leeds City Council tenants living in the City and Hunslet ward (70%) and other applicants with a local connection to the City and Hunslet ward (84%), who have a good tenancy record (85%).

Preference should also be given to people living in overcrowded conditions (80%) followed by members or former members of HM Armed Forces (62%). Just above half of the respondents felt that people living in a home too big for their need should also be given preference (54%).

### **4** Consultation Questions


The first question **"Do you agree that the following groups should be given preference for offers of the new homes (tick all that apply)"** was broken down into 6 sections (labelled Q1A – 1F). Participants were asked to list any other groups they felt should be given preference for housing and to provide additional comments (Q1G).




### Q1A – Leeds Council tenants living in City & Hunslet ward

### Q1B - Applicants who have a good tenancy record





# Q1C – People with a local connection to the City & Hunslet ward





The next question (Q1G) asked which other groups should be given priority. 13 respondents made a written response to this question.

The responses were: homeless people (3); disabled tenants (2); people who rent privately (2); reiterated overcrowding (2); people who have been waiting the longest irrespective of priority band (1); single parents who rent privately (1); people in employment (1); older people (1); good tenants who lived in the area before the original properties were demolished (1).


There were further comments made: people expressed an interest in the properties; people felt good tenants should be rewarded for good behaviour and one expressed a desire to have a multicultural lettings policy to create a multi-ethnic, all-inclusive estate.

#### 5 Equality Monitoring Questions

The next part of the survey focussed on equality monitoring questions including gender, ethnicity, religion, disabilities and caring responsibilities.

The breakdown of the respondents into these categories is shown below:


#### Gender of survey respondents

The ethnicity of those responding to the survey is shown in the chart below:




### **Disability**




### Nature of disability





48% of respondents actively practice their religion.





13% of respondents consider themselves as carers.


## Respondents' housing type
