The park has been designed to incorporate graded trails (green, red, blue) which enables individuals to choose a route suited to their cycling ability. These graded features will cater for beginners, through to expert level. Routes will be signposted in order to maintain a high level of health and safety throughout the park.

Throughout the planning process, LCC has engaged with not-for-profit organisation Cycle Pathways who have gained a good understanding of cyclist profiles in the Leeds City Region. Their development activities on site have been tailored around this, ensuring that the local community is engaged, as well as targeting under-represented groups.

Key findings

Under-represented groups have responded well to activities that have been used to build momentum for cycling in the local area. This includes a female-only ride and run group which operates out of the hub building.

Some features of the park will be able to be used by disabled access bikes. The hub building will ultimately have the capacity to have disability access bikes on offer.

Overall, the completion of the Bike Park will enable LCC to meet the increasing demand for cycling infrastructure in the Leeds City Region. The ambitious plans to build the bike park infrastructure at Middleton Park will lead to an improved visitor experience for all, and enhance the development of activities targeted at underrepresented groups in the sport. It is hoped that the development will increase the capacity of the park to facilitate such activity and in turn that increase visitor numbers, as well as the increasing the variety of individuals that use the facility.

Not only will the development of the park enhance the quality of disused (for any formal activity) area of green space for the Leeds City Region, it will also provide a visitor pull to the park from a wider regional audience. It is hoped that the success of sporting activity catering for a wider range of individuals.

Cycling infrastructure is something that has been in high demand in the Middleton ward area, and as a result there have been various cycling/mountain bike enthusiasts whom have created trails in the woods already. These trails are not condoned by LCC or any official cycling bodies. LCC's offer of a brand new Bike Park, created by professionals, aims to positively respond to attempts to create cycling infrastructure on site already through providing a safe, fun environment for a variety of different abilities to ride in.
