- **Main aim**
The Children’s Services ‘Turning the Curve’ plan has successfully reduced the number of looked after children by reducing the number of external residential and independent fostering placements. To support this strategy, the refurbishment of the identified home will ensure Leeds City Council meets national guidance for living standards in children’s homes. It will improve the authority’s capacity to offer better quality in-house placements designed to be short term where ever possible, at a lower cost to external residential placements. The programme of works will provide a more cost effective range of provision for children who need to be looked after even for a temporary period
- **Purpose**
A screening exercise has been carried out to determine if the internal refurbishment will impact upon equality. Leeds City Council has a duty to offer sufficient and suitable accommodation for all Children and Young People who need to be accommodated and looked after. The internal refurbishment will

reduce the institutional feel and update the décor throughout the building.

Periodic discussions have taken place with colleagues at key junctures within the refurbishment scheme. All comments have been incorporated into the final proposals.
- **Councillor Briefing Sessions.**
Local ward members have been informed of the proposal via a programme wide briefing note and will be kept informed of progress. Any appropriate alterations or recommendations required have been included in the project.
- **Staff and Young People at Luttrell Crescent Children's Home.**
The staff and residents have been consulted throughout the design process and periodically updated on progress. This level of engagement has enabled any feedback / comments to be incorporated into the final design.
