Summary of main issues

- A programme to improve the education and support for children and young people with complex social, emotional and mental health needs (SEMH) was approved by Leeds City Council Executive Board in November 2015. The programme will be implemented by Children's Services and seeks to replace the existing outdated and costly provision by providing three new specially designed facilities.
- 2. The South Leeds SEMH facility at Belle Isle is currently under construction on the vacant former 'Merlyn Rees High School' site, adjacent to the South Leeds Youth Hub on Belle Isle Road.
- 3. The Planning permission requires a new controlled pedestrian crossing off Belle Isle Road, negotiated following requests by the Local Councillors. A proposal for a new zebra crossing and improvements to the Middleton Road junction have subsequently been developed.
- 4. The proposals presented will discharge the conditions for external highway works required by the planning consent.
- 5. This report is therefore presented to seek approval for the Section 23 notice advertisement and the construction of the new zebra crossing off Belle Isle Road.

Recommendations

The Chief Officer (Highways and Transportation) is requested to:

- i) note and approve the contents of this report;
- ii) Approve the posting of a formal notice under Section 23 of the Road Traffic Regulation Act for a new "zebra" controlled crossing on Belle Isle Road: and
- iii) Give authority to incur expenditure of £62,208 work costs and £9,381 staff costs to be funded by the Children's Services Capital Plan.

1.0 Purpose of this report

- 1.1 The purpose of this report is to:
 - To seek approval for the posting of a formal notice under Section 23 of the Road Traffic Regulation Act for a new "zebra" controlled crossing on Belle Isle Road.
 - Seek approval to design, supervise and implement the works.

2.0 Background information

- 2.1 In November 2015, the Executive Board approved the principles and direction of the Children's Services "Social and Emotional Mental Health" (SEMH) programme. This programme aims to improve the education and support for children and young people with complex social, emotional and mental health needs and is part of a city wide strategy supported by both the Council and NHS. The current provision is outdated and costly and the SEMH programme intends to improve the service by providing specially designed facilities that will be managed and led by a leading provider of SEMH learning.
- 2.2 Three new facilities are proposed; North Leeds SEMH in Horsforth, East Leeds SEMH in Seacroft and South Leeds SEMH in Belle Isle. A budget of £45 million to deliver the SEMH programme was subsequently approved by the Executive Board on 27th July 2016.
- 2.3 The South Leeds SEMH is located on the site of the vacant former 'Merlyn Rees High School' site, adjacent to the South Leeds Youth Hub, Belle Isle. Construction of the facility is underway and programmed to be complete by February 2018.
- 2.4 The Council already have a mini S278 agreement with the school contractor, Interserve Construction Ltd, to construct the new vehicular access into the school car park.
- 2.5 A detailed design has now been developed and Stage 1 & 2 Safety Audit has been completed.

3.0 Main issues

- 3.1 The full design proposals are shown on drawing no. 299456/LCC/ HWT/XX/DR/EP/GA_01a.
- 3.2 A new zebra crossing is proposed on Belle Isle Road, as requested and supported by the Local Councillors.
- 3.3 Additional design proposals include a pedestrian access into the new facility's car park, various new traffic signs, new white lining and an existing pedestrian crossing point closed to encourage the use of the new crossing facilities.
- 3.4 Construction of the facility is underway and programmed to be complete by February 2018. The Highways site works constitute approximately 6 weeks' work, to be complete by March 2018. The school handover is programmed for the 16th March 2018, with the school opening date on the 9th April 2018.
- 3.5 The Local Councillors have negotiated that the school's new facilities are available to the community outside of the defined school hours and on weekends. South Leeds SEMH school will have a full size community accessible artificial turf pitch. Usage of this pitch by the local community will be managed via the adjacent Leeds Youth Hub. Community usage will extend to the staff car park and adjacent multi-use games court.
- 3.6 Parking is abused on the central reservation during the sport matches on the playing fields, the Traffic department will be supporting the scheme with a Traffic funded TRO to prevent parking on the verge and footway.

4.0 Funding

4.1 The cost of the highway works are currently estimated as £71,589 and will be funded from the Children's Services Capital Plan. We have approval to inject funds from the Children's Services Capital Plan from the £45 million SEMH budget.

5.0 Programme

- 5.1 Construction of the facility has started and is programmed to be complete by February 2018.
- 5.2 The Highways site works constitute approximately 6 weeks' work, to be complete by March 2018. A start date is to be confirmed with the Highways term Contractor.
- 5.3 The Traffic department will be enforcing a TRO this year, to prevent parking on the verge and footways by the zebra crossing.

6.0 Corporate Considerations

6.1 Consultation and Engagement

- 6.1.1 During the Planning process the proposed development of the three new SEMH schools has been subject to extensive and on-going engagement with key stakeholders including local community groups in South Leeds, the South Leeds Youth Hub, members of staff at the current provision, Asset Management, City Development, Parks & Countryside, Planning Department and the Principal Landscape Architect for Leeds City Development.
- 6.1.2 The Local Councillors have been consulted and are happy with the proposals. The introduction of the new pedestrian crossing was at their request.
- 6.1.3 Discussions took place with the Highways Traffic Department as part of the internal consultation. The Traffic department have agreed to fund a TRO to support the scheme and prevent parking on the central reservation and footway.
- 6.1.4 As part of the external consultation the emergency services, WYCA and local residents were notified of the highway proposals between the 20th & 25th April 2017. No objections were received.
- 6.1.5 Safety Audit: A Stage 1 & 2 Safety Audit have been carried out and its comments and recommendations have been taken into consideration resulting in some modifications, including new signage added at the central reservation cut-throughs at the junction with Middleton Road and tapered hatching to narrow the approach at the zebra crossing.

6.2 Equality and Diversity / Cohesion and Integration

- 6.2.1 An Equality Impact Assessment Screening has been completed and found no detrimental impacts to any groups, with positives for the local community and those groups most likely to access the new facility.
 - Positives Providing a safe controlled crossing across Belle Isle Road to benefit all users in particular parents with children and people attending the sports matches on the playing fields or attending the new SEMH facilities.
 - Negatives The new zebra crossing may result in a slight increase in traffic congestion during peak periods if demand on the crossing is significant, however this is mitigated by the pedestrian safety aspect of the scheme.

6.3 Council policies and City Priorities

- 6.3.1 These proposals are being brought forward to meet the Council's statutory duty to ensure there are sufficient school places for children with a statement of special needs or education and care plan, which names social and emotional mental health (SEMH) as the principle need.
- 6.3.2 The proposals also contribute to the outcomes and priorities in the Leeds Health and Wellbeing Strategy 2016-2021, specifically promoting mental health equality.
- 6.3.3 The proposal contributes to the city's aspirations to the Best Council and the Best City in which to grow up: a child friendly City, through the creation of provisions that offers children in Leeds the opportunity to benefit from outstanding, integrated

provision, which best meets their behaviour needs. That in turn, will increase attendance, attainment and progression to education, employment and training among some of the most vulnerable children, as desired by the Children and Young People's Plan.

6.4 Resources and value for money

- 6.4.1 **Full scheme estimate:** The cost of these highway works is estimated at £71,589 which consists of £62,208 of works, and £9,381 staff costs.
- 6.4.2 A Design and Cost Report for the injection of funds into the Children's Services Capital Plan for the South Leeds SEMH has been approved.
- 6.4.3 The funds will be drawn directly from the Children Services Capital Plan.
