2. Please provide a brief description of what you are screening

There are currently 164 pharmacies across Leeds contracted to deliver a supervised consumption service and the current contracts will expire on 31 March 2018. This screening document considers the potential impact of awarding interim contracts to existing providers for a period of three months from 1 April 2018 to 30 June 2018 to ensure continuity of provision whilst longer term requirements of the service are determined.

A review of provision is underway but further work is needed so that a fully-informed decision regarding the required service specification and pricing model that will deliver best value for the longer term commissioning of the service can be made. The intention being to complete the review late February 2018, seek approvals in March/April and go out to tender in April / May with new contracts effective from 1 July 2018.

The supervised consumption service is a key element in the treatment of opiate substance misuse for those undergoing treatment through the Forward Leeds service. Many service users have multiple complex needs and are from priority client groups including those who are homeless / vulnerably housed, affected by domestic violence or with a history of offending. Many

have enduring mental and or physical health needs and are from some of the most deprived areas of Leeds. Any break in the continuity of treatment can lead to set backs in treatment and clients disengaging which can have adverse impacts om health and well-being.

Ensuring continuity of provision will ensure that this vulnerable client group continues to have access to safe and effective drug treatment services in accordance with recommended best practice for safe and effective treatment as set out in the Department of Health's Drug Misuse and Dependence: UK guidelines on clinical management (updated 2017).

• Key findings

The main impact is positive in that all key groups will be able to continue their treatment and have choice over where this takes place. Service users are free to choose whichever pharmacy they prefer and a number of factors can influence which one they use, from proximity to home or work to being away from where they source their drugs. Maximising the number of pharmacies able to offer the service increases the choice that service users have and the likelihood of them remaining engaged in treatment and resulting in a positive outcome. This gives equal opportunity of access irrespective of where a service user lives and minimises travel costs that might be incurred for those on low incomes.

Engaging people in treatment provides them with improved opportunities to overcome their dependency and make a positive contribution to their family and community. Helping people lead drug free lives brings wider benefits to communities in Leeds by reducing the burden on other services and contributes to a reduction in crime. It is estimated by Public Health England that 72,804 crimes were prevented in Leeds in 2016/17 as a result of drug users being in treatment in the city.

The proposal will also help maintain the trust and confidence of pharmacies in their business relationship with the Council which may be damaged if existing contracts are allowed to lapse without formalising ongoing arrangements. Many of them are small independent pharmacies for which reassurance of business arrangements is key.

It is not anticipated that there will be a differential impact between different client groups.
