Demolition of 19 garages, 17 of which are empty, is required. The majority of garages are in a poor state of repair and causing a blight to the landscape. Demolition is supported by the local community, Housing Office and Ward Members.

The majority of the garages are empty – only two are currently occupied. There are no known implications for specific groups.

Consultation has taken place about the demolition proposal with Ward Members, Local residents and existing tenants of the garages.

Removal of the garages impacts in that there will no longer be garages to rent at this

 There is a positive impact on the community if new housing is developed here creating much needed new homes for families to occupy and will be constructed to current standards and meet lifetime homes accessible regulations.

**Demolition of the garages removes the blight they currently have on the area so the visual aspect will be immediate following demolition. The wider site offers opportunity to remove overgrown vegetation and create a more positive use of the site for new housing.**
