A review of housing related support has taken place over the last two years and new services have been commissioned. The new model for housing related support includes visiting support and accommodation services.

A review of the Raise provision within the context of the new housing related support model and in particular the services that may be required to support people who are homeless and / or rough sleeping is underway. The purpose of the review is to determine future commissioning needs and includes consultation with a range of stakeholders including members, council directorates, other partners, providers and service users.

The current contract will expire before this review can be completed. In order to maintain service continuity, the proposal is to use the available contract extension to run to 31st March 2019.
