## 2. Please provide a brief description of what you are screening

Leeds City Council commissions the family healthy living programme which delivers services promoting healthy weight for children and families by providing physical activity and healthy eating sessions along with developing children's and parents' skills and confidence to lead a healthy life.

The family healthy living programme is currently delivered through three third sector family healthy living providers which are Dance Action Zone Leeds (DAZL), LS-TEN and Health for All (Leeds) Ltd. The annual value is £180,520, broken down as follows:

£83,040 – Health for All delivering multi-game and cooking activities

£18,960 - LS-TEN delivering skateboarding / bike riding activities and cook and eat sessions

£78,520 – DAZL delivering dance activities and cooking activities

Approval is requested to directly award contracts in respect of the family healthy living programme contracts with DANCE ACTION ZONE LEEDS, LS-TEN and Health for All (Leeds Ltd) for a period of 3 years commencing on 1<sup>st</sup> April 2024 (with an option to extend for a period of up to 24 months in any combination) The new contracts will ensure continuity in the delivery of the integrated family healthy living service and ensure that the provision of work in Leeds most deprived communities and among families at increased risk of obesity is continued.
