The application premises is located in a mixed-use area of both retail premises and residential accommodation. There are residential flats above and a back-to-back property to the rear. This application is for the sale alcohol from 10:00 hours to 23:00 hours which is to complement the golf simulation business. However, the closing time is the same, 23:00 hours, and without any drinking up time there is a risk of public nuisance from anti-social behaviour from customers leaving the premises either having drunk their drinks too quickly or by taking their drinks with them and drinking outside.

Having considered the application under the Licensing Act 2003 for the above premises, we consider that the following measures are relevant and reasonable in order to meet the following aim of the licence:

• Prevention of public nuisance

#### **Noise and Vibration**

- 1. The sale of alcohol shall be from 10:00 hours to 22:30 hours every day.
- Licensable activities shall be conducted and the facilities for licensed activities shall be designed and operated so as to prevent the transmission of audible noise or perceptible vibration through the fabric of the building or structure to adjoining properties.
- 3. Noise from a licensable activity at the premises will not be audible at the nearest noise sensitive premises at Flat 1, 2, 3 and 4, 20xford Street LS20 9AX.
- 4. Bottles will not be placed in any external receptacle between 11 pm and 7 am the following day to minimise noise disturbance to neighbouring properties.
