## 2. Please provide a brief description of what you are screening

Adults and Health propose to spend £470k in 2024/25 for the delivery of adaptations in non-council stock. This includes minor adaptations costing less than £1,000 and ceiling tracking hoists, neither of which are eligible for funding through a Disabled Facilities Grant administered by Resources and Housing. An equal service is provided to Council tenants by Housing Leeds.

All works are carried out following recommendation by a range of staff in health and social care and are an important element of the preventative approach and to the safety of older and disabled people and their carer's. The minor adaptations are carried out by Leeds Building Services and a contract is in place for the provision of ceiling hoists.

The Director of Adult Social Services is recommended to approve the release of £470,000 capital for 2024/25 for the continued delivery of this service.
