2. Please provide a brief description of what you are screening

This screening relates to a decision being presented at Adults and Health Delegated Decision Panel in March where approval is being sought for the following:

- To extend the existing LCC contract for the Touchstone Community Support Team service for a six month period from 1st April 2024 to 30th September 2024.
- To approve the transfer of funding from the Council to the NHS Leeds ICB for the Touchstone Community Support Team service, with the ICB becoming lead commissioner for the provision. The existing Section 256 arrangement will be used for this funding transfer from 1st October 2024.

The invocation of the six month extension period to the Touchstone Community Support Team service will involve no change to service delivery, therefore it is anticipated that

there will be no negative impact on any of the protected equality characteristics as a result of this decision.

The funding transfer from the Council to the ICB may include a small efficiency saving to the Council element. Commissioners from LCC and the ICB are working very closely with the provider and key stakeholders to ensure that any agreed saving is absorbed without impacting on front line service delivery, and that there are no unintended consequences for protected groups.

The ICB will become lead commissioner for the CST service going forward, with the rationale being that this service has a clearer fit with NHS and health pathways and systems, rather than social care. ICB colleagues have indicated that they do not predict making any substantial changes to the service in the near future. Any possible changes would first be subject to an NHS equality impact assessment.
