2. Please provide a brief description of what you are screening

Injection of an additional £2.3m in funding allocation from the Transforming Cities Fund towards the A64 Bus, Walking and Cycling project. Injection and approval to spend development funding of £561,000, and approval to amend the existing funding agreement with WYCA for this scheme, to reflect the additional development funding.

The project will provide a series of bus service improvements along the A64 corridor via new inbound bus lanes, traffic signal upgrades, junction improvements and real time information. Improved pedestrian and cycling crossing facilities are also to be provided at targeted locations.

4. Considering the impact on equality, diversity, cohesion and integration (EDCI)

• How have you considered equality, diversity, cohesion and integration? Equality, diversity, cohesion and integration have been considered when designing the A64 bus walking and cycling corridor improvement project. The project aims to deliver improvements for bus services (journey time savings, reliability and passenger information), and also makes improvements for cycling, walking and wheeling through new and improved crossing facilities.

It is acknowledged that the designs are not complete, and so there may be some gaps within this EDCI screening document. The intention is to produce a further, more detailed screening document and/or full EIA, once the detailed designs are completed.

The project aims to deliver benefits for bus users along the corridor through journey time savings, improved reliability and improved real time passenger information. It is acknowledged that women, older people and younger people are more reliant on bus services and more likely to use buses - this is partly linked to the relative affordability of public transport and to likelihood of car ownership / ability to drive. The scheme benefits are therefore anticipated to disproportionately affect people with these characteristics.

The project also looks to deliver improved pedestrian crossing facilities. The pedestrian crossings at Inglewood Drive, Moresdale Lane, and Seacroft Avenue have been revised to enhance the provision for pedestrians crossing the carriageway, and improve safety. This is achieved through widened crossing space, realigned tactile arrangements and shorter or completely removed pedestrian staggers. These changes are anticipated to disproportionately benefit more vulnerable people who are walking and wheeling such as children, older people and disabled people.

Improvements to the cycling provision along the corridor is achieved through new and improved crossing facilities. This is seen to improve both the safety and perception of safety for people who are cycling and will disproportionately benefit more vulnerable and less confident cyclists such as children and younger people.

National and LCC standards for cycle infrastructure design and safety have been incorporated into the designs. The designs are additionally going to be reviewed by the WYCA Quality Panel.

Key finding

Evidence suggests that women, younger people and older people tend to be more reliant on buses and more likely to use buses across Leeds. The project is anticipated to deliver benefits to bus users in terms of reliability, time savings and real time information provision. These benefits will therefore disproportionately affect people within these groups.

The scheme is anticipated to result in key benefits for bus users, and people who are walking, wheeling or cycling. These benefits are anticipated to disproportionately affect groups with protected characteristics – particularly, women, disabled people, younger people and children, and older people.

Actions

A further, more detailed EDCI screening or full appraisal on the Detailed Designs will be undertaken.
