The service delivered via these arrangements sees all adopted footpaths in Leeds treated with herbicide along with hard surfaces and communal areas within housing estates managed by Housing Leeds. In this context there are no identified differential equality impacts on any of the equality characteristics.

- **Key findings**

Reduced levels of weed infestation within footways provides improved safety and ease of access, providing additional benefits to visually impaired users (reduced trip hazards and obstacles to using a stick effectively) and those with mobility issues. Implementing the decision to extend existing arrangements will continue to realise these benefits
