Decision for the 12-month extension of an existing cooperation agreement with Leeds Community Healthcare NHS Trust (LCHT) for continued delivery of the multi-disciplinary model of adoption assessment and support across West Yorkshire in 2024/25. This model, which was the first of its kind developed as part of the government's adoption regionalisation reforms, continues to demonstrate positive impact for families and is supported by health and local authority funding partners across West Yorkshire. This agreement is an essential element of the model, ensuring clear expectations and objectives are in place with LCHT to deliver the health posts which are embedded in the multi-disciplinary team.
