Decision to approve transfer funding by way of a section 76 to NHS West Yorkshire Integrated Care Board (Leeds Based) for delivery of the Social, Emotional and Mental Health (SEMH) Cluster Based Support: MindMate Wellbeing service - for 2024/25.

Leeds City Council is committed to joint funding the service throughout the life of the framework. However, funding will be made available on an annual basis and as such this report seeks approval to transfer funding for 2024-25 financial year at the value of £250,000.

This decision supports the ambitions of the Best Council Plan and the ambitions of a Child Friendly City, including improving educational attainment and closing achievement gaps for children and young people vulnerable to poor learning outcomes; improving social, emotional and mental health and wellbeing; and helping young people into adulthood, to develop life skills and be ready for work.
