2. Please provide a brief description of what you are screening

This screening relates to the acceptance of grant funding from the Office of Health Improvement and Disparities to increase and enhance substance misuse treatment in the city.

The Supplemental Substance Misuse Treatment and Recovery Grant (SSMTRG) is intended to increase the number of people in treatment (20% nationally), reduce drug-related deaths, increase engagement of those leaving prison treatment services and improve service quality by increasing the staffing levels across treatment services and reducing caseloads. The allocation for 2024/25 is £8,212,541.

The Supplementary Substance Misuse Treatment & Recovery Housing Support Grant (HSG) is a three-year test and learn project running in a limited number of local authority areas with the aim of increasing the number of people recovering from addiction in stable and secure housing. The allocation for 2024/25 is £588,237.
