This screening relates to the acceptance of grant funding from the Office of Health Improvement and Disparities to increase stop smoking services and support in the city.

In October 2023, the government announced a new five-year investment programme of £70 million per year to support local authority-led stop smoking services. Leeds' allocation for 2024/25 is £985,430 and is to be used to:

- build capacity to deliver expanded local stop smoking services and support;
- build demand for local stop smoking services and support; and

- increase the number of people setting a quit date and 4-week quit outcomes
