We have previously secured the extension of the Cumulative Impact Assessment (CIA) to Weetwood and believe it should be referenced in the Licensing decision. In order to not add to the cumulative drinking problem in the area we propose these conditions: Alcohol must be consumed seated No admittance to groups in fancy dress/or engaging in 'the Otley Run' These conditions were accepted recently for the comparable 'Residence' venue in Headingley, again in reference to the CIA, and that premises appears to be thriving. Additional points: Opening Hours - we are concerned that 1am is too late for Monday to Saturday. There are two blocks of older people's apartments directly opposite the premises. A noisy premises open until 1am every weekday is imbalanced. We propose 11pm finishing Sunday-Thursday and perhaps midnight for Friday/Saturday for example. Also, will there be outdoor seating? This would make late opening hours significantly more of a problem. Parking - there are parking issues in that area. Would visitors to the restaurant have parking provision? There is a small car park opposite Catch, can this be guaranteed for use? And a great benefit to the community would be to allow Weetwood Primary school parents to use this car park for free up to 9am to make school drop off easier. Neighbourhood / environment - a commitment to help keep the area clean especially from any takeaway containers. Finally - the inclusion of a 'function room' is welcome for local community groups, it should be ensured that this is accessible.



Comments:	12/03/2024 10:37 AM I write to object to application PREM/05295/001 for a new premises licence at 9 Weetwood Lane, Weetwood, Leeds LS16 5LT. I object that the application represents a threat to the licensing objectives of the prevention of public nuisance and the protection of children from harm.
	The application is ludicrous. In the midst of a quiet suburban area it proposes an establishment remaining open until 1am every night (except 12.30am on Sunday night), selling alcohol and refreshments until half-past midnight every night (except midnight on Sunday). And this is in an area comprising residential streets, including Weetwood Lane itself, St Chad's Road, Glebe Terrace, Hollin Road and Hollin Lane. Furthermore, the proposal is immediately beside Orchard Court and St Chad's Court, housing for older people, and it's almost beside Weetwood Primary School. In the middle of the night, customers will be leaving, shouting and banging car doors, thereby keeping families awake into the early hours.
	The application's enthusiasm for the sale of alcohol implies that it is in fact vying for a share of the lucrative Otley Run, which passes nearby, calling at both Woodies and the Three Horseshoes pubs, which are just around the corner on Otley Road. Attracting the pub crawl off the main road would further increase public nuisance in the area, comprising the well known noise, vomiting and urination which follow.
	Therefore, I respectfully request that the Licensing Sub-Committee REFUSE application PREM/05295/001.

We are proposing a couple of conditions, and key points we would like the Sub Committee to bear in mind.

We have met with the applicant and his agent and believe they would be supportive of what we \Box re suggesting. It was a positive meeting.

 \Box We support the establishment of a new family restaurant in this location. We're sure the new owners will turn it into another thriving local business, which is really welcome.

However, it is well established that there is a need to limit the negative 'cumulative' impact of the Otley Run in this area of Weetwood. We have previously secured the extension of the Cumulative Impact Assessment (CIA) to Weetwood and believe it should be referenced in the Licensing decision.

In order to not add to the cumulative drinking problem in the area we propose there should be no admittance to groups of adults in fancy dress/or engaging in 'the Otley $Run\Box$.

A similar condition was recently accepted recently for the comparable 'Residence' venue in Headingley, again in reference to the CIA, and that premises appears to be thriving.

We believe the applicant would be open to accepting this condition.

Additionally, we are concerned about Otley Run groups buying takeaway from the venue. This would encourage more litter and - more worryingly - large groups of people who are often already drunk eating on the street in a busy pedestrian thoroughfare, close to older people's accommodation. Please consider how this might be tackled as part of the licensing conditions.

Additional points:

Opening Hours - we think it is important that people should not be able to sit and drink/eat in the outdoor area past a reasonable time. We understand that a condition along these lines has been accepted.

Parking - there are parking issues in that area. Would visitors to the restaurant have parking provision? There is a small car park opposite Catch, can this be guaranteed for use? And a great benefit to the community would be to allow Weetwood Primary school parents to use this car park for free up to 9am to make school drop off easier.

Neighbourhood / environment - a commitment to help keep the area clean especially from any takeaway containers.

Finally - the inclusion of a 'function room' is welcome for local community groups, it should be ensured that this is accessible."



We object to the opening hours of Monday to Saturday from10:00am to 01:00am and Sunday from 10:00 am to 12:30 am. Closing at 1am is far too late and we would recommend closing at 11pm every day. Reasons being that staying open until late and serving alcohol is likely to increase crime and disorder, reduce public safety and increase public nuisance (particularly noise) in the neighbourhood. Even controlled noise from the venue is also more likely to disturb sleep thus granting of the licence would increase the likelihood of harm to children. The stated condition "The premises licence holder/designated premises supervisor shall ensure patrons use the external areas in a manner which does not cause disturbance to

residents and business in the vicinity". There are already several hospitality businesses in the area where this is not managed appropriately at all times. In what way will this particular business achieve this condition? The area been recently included in the Cumulative Impact Assessment Area so the inclusion of a business that provides pizza for in house and takeaway will be more than likely to make most of its profit from the sale of alcoholic beverages. It is for the business to convince the licensing authority that the four conditions "-prevention of crime and disorder - protection of children from harm - public safety - Prevention of public nuisance" will actually be guaranteed.

We cannot see any information other than "opening hours", "activities" and "conditions" on the public access website. We have been told by our Weetwood Councillors that this application is family focused pizza restaurant, cocktail bar, and function room and we can only assume that this is what our Councillors have been led to believe despite the obvious appearance of the licence application being for late night alcohol & refreshment (pizza) & takeaway pizzas. Which is it?
