# 1.0 Purpose Of This Report

# 2.0 Background Information

Metro are trialing a process undertaking Locality Based Accessibility Planning and invited Outer North west Leeds Area Committee to participate in a pilot.

Improving access to services is a central theme of the 2<sup>nd</sup> West Yorkshire Local Transport Plan (WYLTP) 2006–11. The aim of the pilot is to identify the Local Accessibility Priorities for each area together with an Accessibility Action Plan which Metro, the council, transport operators and other agencies can carry forward.

#### 3.0 Main Issues

### **Process and Engagement**

Metro undertook an accessibility mapping exercise and presented the outcomes to meetings in Horsforth, Rawdon and Yeadon together with a drop in session in Otley Market Place. Questionnaires were issued to attendees and the results were collated and analysed.

#### **Local Accessibility Priorities**

The thee key Local Accessibility Priorities in Outer North West Leeds identified by the consultation process are

- Improved links to local rail stations at Guiseley, Menston, Ilkley and Horsforth
- Improved links between towns/villages in the area
- Increased frequency and quality of bus service to Leeds with onwards operations to the major hospitals

Attached to this report is the Accessibility Action Plan for Outer North West Leeds.

# 4.0 Implications for Council Policy and Governance

### Member Consultation

The pilot has been overseen by the Area Committee's Business and Transport Sub Group.

### 5.0 Legal and Resource Implications

The process of Locality Accessibility Planning does not in itself identify discrete funding to address the issues raised. Its aim is to inform the delivery of currently funded services provided by Metro, Leeds City Council and others to ensure they more effectively target local needs.
