

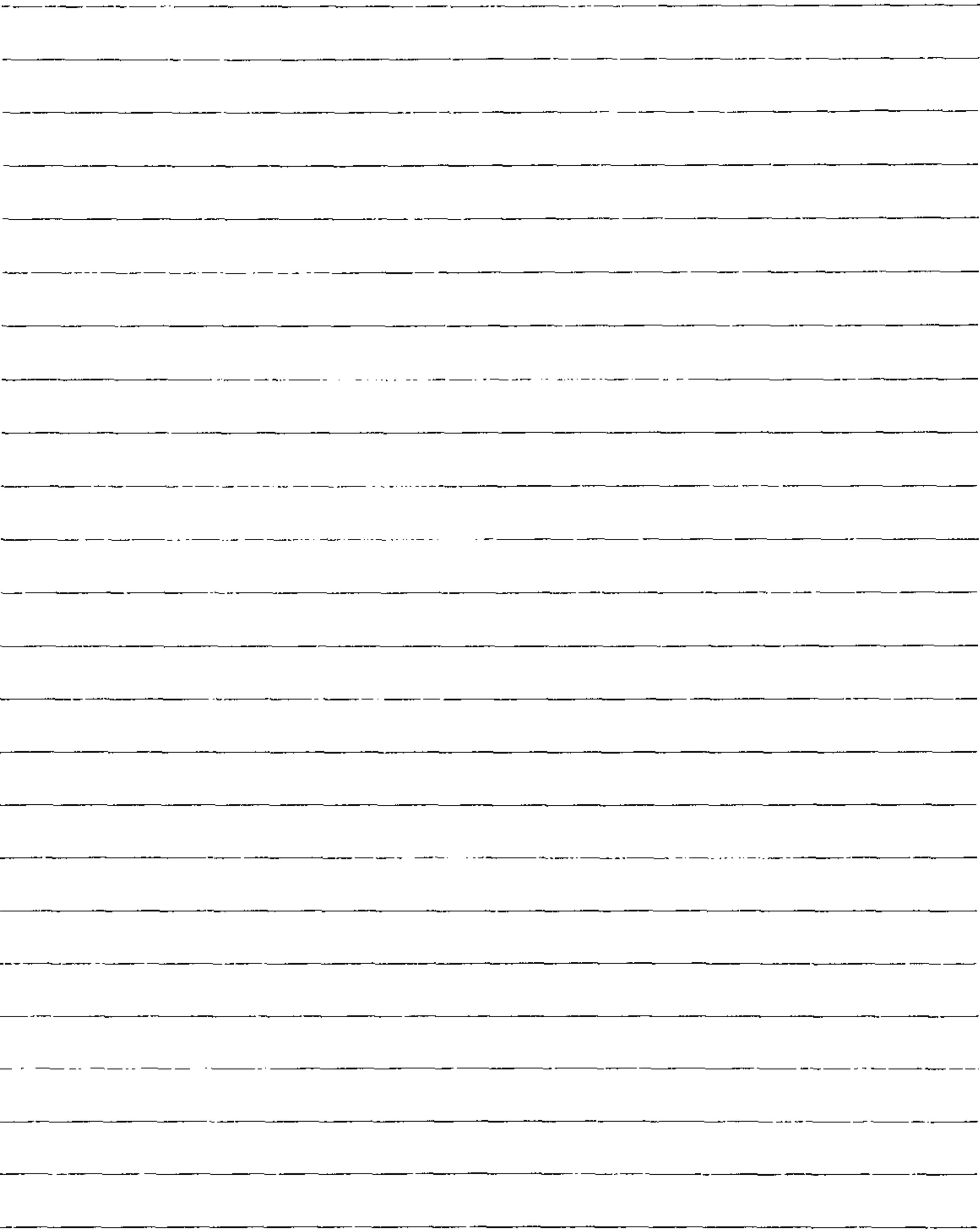
My husband and I have been members of the Seacroft Green Social Club for 15yrs. We are now retired, but enjoy our weekends at the club.
