## 1.0 Introduction

- 1.1 At the last meeting reference was made to the Board's decision in June 2010 to undertake an inquiry on Kirkgate Market. It was reported that as the Executive Board had asked that officers submit a draft market strategy to its meeting on 13<sup>th</sup> October there was no time for scrutiny to undertake a detailed inquiry. Instead the Board would be invited to comment on the draft strategy in September prior to this being considered by Executive Board. Members agreed this approach.
- 1.2 Members of the Board also agreed that arrangements be made to visit Kirkgate Market in late August 2010 and be briefed by the Head of City Centre and Markets and meet some of the market traders.

## 2.0 Current Position

- 2.1 The Head of City Centre and Markets has advised that the development of a draft market strategy will not be completed in time for the Scrutiny Board to comment at today's meeting. As a consequence and in order for this Scrutiny Board to have an input to the draft strategy the Executive Board has agreed to consider this matter at its meeting on 3<sup>rd</sup> November 2010. This Board will now consider the draft strategy at its meeting on 5<sup>th</sup> October 2010.
- 2.2 Members of the Board visited Kirkgate Market on 25<sup>th</sup> August 2010 and received a briefing on the current issues facing the market and met a number of traders in the market hall. A note of the visit is attached for your information as appendix 1 to this report.
