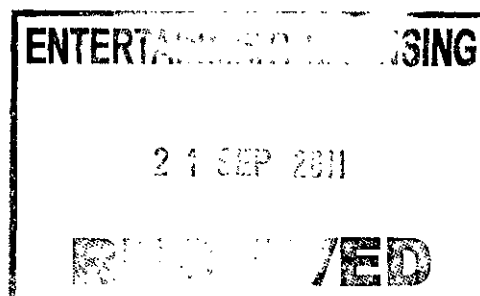
We the undersigned wish to object to the granting
