The premise is a former church situated in a highly populated area of Headingley with residential on all sides. The premise has been operating as an event space for a variety activities for some time with the use of occasional Temporary Events Notices. To date, there have been no complaints regarding noise. This application is for sale of alcohol and regulated entertainment including live music indoors and outdoors until 2300 hours weekdays and 0100 hours Friday and Saturday. Although the proposal is for only unamplified sound to be performed outside, this is formalised in a condition below.

Having considered the application under the Licensing Act 2003 for the above premises, the Leeds City Council's environmental action service considers that the following measures are proportionate and necessary in order to promote the following licensing objective:

Prevention of public nuisance

Noise and Vibration

- 1. Noise from a licensable activity at the premises will not be audible at the nearest noise sensitive premises which are Cardigan Road, Thornville Court and The Beamsleys.
- 2. There shall be no external loudspeakers attached to the building.
- 3. Live music performed in the outside area should no be amplified and should cease at 2200 hours.
- 4. The PLH/DPS will ensure patrons external areas in a manner which does not cause disturbance to nearby residents and business in the vicinity. Patrons will not use such areas after 2300 hours except for smoking.
- 5. The activities of persons using the external areas shall be monitored after 2300 hours and they shall be reminded to have regard to the needs of local residents and to refrain from shouting and anti social behaviour etc when necessary.

Transport / Pedestrian Movement

6. Clear and legible notices will be displayed at exits, car parks and other circulatory areas requesting patrons to leave the premises quietly having regard to the needs of local residents, in particular emphasising the need to refrain from shouting, slamming car doors, sounding horns and loud use of vehicle stereos and anti-social behaviour.
