Scrutiny Board (Housing and Regeneration)

The Scrutiny Board (<u>Housing and</u> Regeneration) is authorised to discharge the following overview and scrutiny functions¹.

- to review or scrutinise <u>decisions made or other action taken in connection with</u> any council or executive function or any matter which affects the authority's area or the inhabitants of that area;²
- 2. to review or scrutinise the performance of the Housing and Regeneration Partnership Board;³
- 3. to carry out such other reviews or policy development tasks as it may be requested to do by either the Executive Board or the Council:
- to act as the appropriate Scrutiny Board in relation to the Executive's initial proposals for a relevant plan or strategy⁴ within the Budget and Policy Framework;⁵
- 5. to review or scrutinise executive decisions that have been Called In;
- to review outcomes, targets and priorities within the Council Business Plan and the Best city ..to live priorities within the City Priority Plan;
- to receive requests for scrutiny and councillor calls for action and undertake any subsequent work; and
- 8. to make such reports and recommendations as it considers appropriate and to receive and monitor formal responses to any reports or recommendations made.
